RELATING TO ELECTIONS - RESIDENCE OF THOSE IN GOVERNMENT CUSTODY  
ACT

It is enacted by the General Assembly as follows:

1 SECTION 1. Title 17 of the General Laws entitled "ELECTIONS" is hereby amended by  
2 adding thereto the following chapter:

3 CHAPTER 30

4 RESIDENCE OF THOSE IN GOVERNMENT CUSTODY ACT

5 **17-30-1. Title.** – This chapter shall be known and may be cited as the "Residence of  
6 Those in Government Custody Act".

7 **17-30-2. Legislative declaration and findings.** – The purpose of this chapter is to ensure  
8 that persons in government custody within the state are counted at their actual residence for  
9 redistricting purposes. The general assembly notes that Rhode Island general laws section 17-1-  
10 3.1 provides: "A person's residence for voting purposes is his or her fixed and established  
11 domicile... A person can have only one domicile, and the domicile shall not be considered lost  
12 solely by reason of absence for any of the following reasons:... Confinement in a correctional  
13 facility..." Investigation has shown that, despite these provisions, the census classifies  
14 incarcerated persons as residents of their places of incarceration rather than of their home  
15 addresses. The provisions of this act are necessary to provide procedures and duties to correct this  
16 discrepancy.

17 **17-30-3. Electronic record.** – The department of corrections shall collect and maintain  
18 an electronic record of the legal residence, presumptively outside of the facility, and other

1 demographic data, for any person entering its custody after January 1, 2015. At a minimum, this  
2 record shall contain the last known complete street address prior to incarceration, the person's  
3 race, whether the person is of Hispanic or Latino origin, and whether the person is over the age of  
4 eighteen (18).

5 **17-30-4. Reports to the secretary of state.** – (a) In each year in which the federal  
6 decennial census is taken but in which the United States bureau of the census allocates  
7 incarcerated persons as residents of correctional facilities, the department of corrections shall, by  
8 May 1<sup>st</sup> of that same year, deliver to the secretary of state:

9 (1) The street address of the correctional facility in which such person was incarcerated at  
10 the time of such report;

11 (2) The last known address of such person prior to incarceration or other legal residence  
12 (if known);

13 (3) The person's race, whether the person is of Hispanic or Latino origin, and whether the  
14 person is over the age of eighteen (18) (if known);

15 (4) Any additional information as the secretary of state may request pursuant to law.

16 (b) The department shall provide the information specified in subsection 17-30-4(a) in  
17 such form as the secretary of state shall specify.

18 (c) Notwithstanding any other provision of the general or public laws to the contrary, the  
19 information required to be provided to the secretary of state pursuant to this section shall not  
20 include the name of any incarcerated person and shall not allow for the identification of any such  
21 person therefrom, except to the department of corrections. The information shall be treated as  
22 confidential, and shall not be disclosed by the secretary of state except as redistricting data  
23 aggregated by census block for purposes which they may require.

24 **17-30-5. Federal facilities.** – The secretary of state shall request each agency that  
25 operates a federal facility in this state that incarcerates persons convicted of a criminal offense to  
26 provide the secretary of state with a report including the information listed in section 17-30-4.

27 **17-30-6. Requiring use of data in redistricting.** – The secretary of state shall prepare  
28 redistricting population data to reflect incarcerated persons at their residential address, pursuant to  
29 section 17-30-5. The data prepared by the secretary of state pursuant to section 17-30-5 shall be  
30 the basis of state house of representative districts, state senate districts, and all local government  
31 districts that are based on population. Incarcerated populations residing at unknown geographic  
32 locations within the state, as determined under section 17-30-5 shall not be used to determine the  
33 ideal population of any set of districts, wards, or precincts.

34 **17-30-7. Determinations and data publication by the secretary of state.** – (a) For each

1 person included in a report received under this chapter, the secretary of state shall determine the  
2 geographic units for which population counts are reported in the federal decennial census that  
3 contain the facility of incarceration and the legal residence as listed according to the report.

4 (b) For each person included in a report received under this chapter, if the legal residence  
5 is known and in this state, the secretary of state shall:

6 (1) Ensure that the person is not represented in any population counts reported by the  
7 secretary of state for the geographic units that include the facility at which the person was  
8 incarcerated, unless that geographic unit also includes the person's legal residence.

9 (2) Ensure that any population counts reported by the secretary of state reflect the  
10 person's residential address as reported pursuant to this chapter.

11 (c) For each person included in a report received under this chapter for whom a legal  
12 residence is unknown or not in this state, and for all persons reported in the census as residing in a  
13 federal correctional facility for whom a report was not provided, the secretary of state shall:

14 (1) Ensure that the person is not represented in any population counts reported by the  
15 secretary of state for the geographic units that include the facility at which the person was  
16 incarcerated.

17 (2) Allocate the person to a state unit not tied to a specific determined geography, as  
18 other state residents with unknown state addresses are allocated, including, but not limited to,  
19 military and federal government personnel stationed overseas.

20 (d) The data prepared by the secretary of state pursuant to this section shall be completed  
21 and published no later than thirty (30) days from the date that federal decennial PL94-171 data is  
22 published for the state of Rhode Island.

23 **17-30-8. Use in aid.** – The data prepared by the secretary of state as required by section  
24 17-30-5 shall not be used in the distribution of any state or federal aid.

25 **17-30-9. Severability.** – If any provision of this act or the application of any provision of  
26 this act to any person or circumstance is held invalid, the invalidity does not affect other  
27 provisions or applications of the act that can be given effect without the invalid provision or  
28 application, and for this purpose the provisions of this act are severable.

29 SECTION 2. This act shall take effect upon passage.
