DISCLOSURES

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 5-20.8-2 of the General Laws in Chapter 5-20.8 entitled "Real  
2 Estate Sales Disclosures" is hereby amended to read as follows:

3 **5-20.8-2. Disclosure requirements.**

4 (a) As soon as practicable, but in any event no later than prior to signing any agreement  
5 to transfer real estate, the seller of the real estate shall deliver a written disclosure to the buyer  
6 and to each agent with whom the seller knows he or she or the buyer has dealt in connection with  
7 the real estate. The written disclosure shall comply with the requirements set forth in subsection  
8 (b) of this section and shall state all deficient conditions of which the seller has actual knowledge.  
9 The agent shall not communicate the offer of the buyer until the buyer has received a copy of the  
10 written disclosure and signed a written receipt of the disclosure. If the buyer refuses to sign a  
11 receipt pursuant to this section, the seller or agent shall immediately sign and date a written  
12 account of the refusal. The agent is not liable for the accuracy or thoroughness of representations  
13 made by the seller in the written disclosure or for deficient conditions not disclosed to the agent  
14 by the seller.

15 (b)(1) The Rhode Island real estate commission may approve a form of written disclosure  
16 as required under this chapter or the seller may use a disclosure form substantially conforming to  
17 the requirements of this section. The following provisions shall appear conspicuously at the top of  
18 any written disclosure form: "Prior to the signing of an agreement to transfer real estate (vacant

1 land or real property and improvements consisting of a house or building containing one to four  
2 (4) dwelling units), the seller is providing the buyer with this written disclosure of all deficient  
3 conditions of which the seller has knowledge. This is not a warranty by the seller that no other  
4 defective conditions exist, which there may or may not be. The buyer should estimate the cost of  
5 repair or replacement of deficient conditions prior to submitting an offer on this real estate. The  
6 buyer is advised not to rely solely upon the representation of the seller made in this disclosure,  
7 but to conduct any inspections or investigations which the buyer deems to be necessary to protect  
8 his or her best interest." Nothing contained in this section shall be construed to impose an  
9 affirmative duty on the seller to conduct inspections as to the condition of this real estate.

10 (2) The disclosure form shall include the following information:

11 (i) Seller Occupancy -- (Length of Occupancy)

12 (ii) Year Built

13 (iii) Basement -- (Seepage, Leaks, Cracks, etc. Defects)

14 (iv) Sump Pump -- (Operational, Location, and Defects)

15 (v) Roof (Layers, Age and Defects)

16 (vi) Fireplaces -- (Number, Working and Maintenance, Defects)

17 (vii) Chimney -- (Maintenance History, Defects)

18 (viii) Woodburning Stove -- (Installation Date, Permit Received, Defects)

19 (ix) Structural Conditions -- (Defects)

20 (x) Insulation -- (Wall, Ceiling, Floor, UFFI)

21 (xi) Termites or other Pests -- (Treatment Company)

22 (xii) Radon -- (Test, Company) "Radon has been determined to exist in the State of  
23 Rhode Island. Testing for the presence of radon in residential real estate prior to purchase is  
24 advisable."

25 (xiii) Electrical Service -- (Imp. & Repairs, Electrical Service, Amps, Defects,  
26 [Modifications](#))

27 (xiv) Heating System -- (Type, Imp. & Repairs, Underground Tanks, Zones,  
28 Supplemental Heating, Defects, [Modifications](#))

29 (xv) Air Conditioning -- (Imp. & Repairs, Type, Defects)

30 (xvi) Plumbing -- (Imp. & Repairs, Defects, [Modifications](#))

31 (xvii) Sewage System -- (Assessment, Annual Fees, Type, Cesspool/Septic Location,  
32 Last Pumped, Maintenance History, Defects)

33 "Potential purchasers of real estate in the state of Rhode Island are hereby notified that  
34 many properties in the state are still serviced by cesspools as defined in Rhode Island general law

1 chapter 23-19.15 (The Rhode Island Cesspool Phase-Out Act of 2007). Cesspools are a  
2 substandard and inadequate means of sewage treatment and disposal, and cesspools often  
3 contribute to groundwater and surface water contamination. Requirements for abandonment and  
4 replacement of high-risk cesspools as established in Rhode Island general law Chapter 23-19.15  
5 are primarily based upon a cesspool's non-treatment of wastewater and the inherent risks to public  
6 health and the environment due to a cesspool's distance from a tidal water area, or a public  
7 drinking water resource. Purchasers should consult Rhode Island general law chapter 23-19.15 for  
8 specific cesspool abandonment or replacement requirements. An inspection of property served by  
9 an on-site sewage system by a qualified professional is recommended prior to purchase. Pursuant  
10 to Rhode Island general law § 5-20.8-13, potential purchasers shall be permitted a ten (10) day  
11 period to conduct an inspection of a property's sewage system to determine if a cesspool exists,  
12 and if so, whether it will be subject to the phase-out requirements as established in Rhode Island  
13 general law chapter 23-19.15.

14 (xviii) Water System -- (Imp. & Repairs, Type, Defects) Private water supply (well).  
15 "The buyer understands that this property is, or will be served, by a private water supply (well)  
16 which may be susceptible to contamination and potentially harmful to health. If a public water  
17 supply is not available, the private water supply must be tested in accordance with regulations  
18 established by the Rhode Island department of health pursuant to § 23-1-5.3. The seller of that  
19 property is required to provide the buyer with a copy of any previous private water supply (well)  
20 testing results in the seller's possession and notify the buyer of any known problems with the  
21 private water supply (well)."

22 (xix) Domestic Hot Water -- (Imp. & Repairs, Type, Defects, Capacity of Tank)

23 (xx) Property Tax

24 (xxi) Easements and Encroachments -- The seller of that real estate is required to provide  
25 the buyer with a copy of any previous surveys of the real estate that are in the seller's possession  
26 and notify the buyer of any known easements, encroachments, covenants or restrictions of the  
27 seller's real estate. If the seller knows that the real estate has a conservation easement or other  
28 conservation or preservation restriction as defined in § 34-39-1 of the general laws, the seller is  
29 required to disclose said information and provide the buyer with a copy of any documentation in  
30 the seller's possession regarding the conservation and preservation restrictions. A buyer may  
31 wish to have a boundary or other survey independently performed at his or her own expense.

32 (xxii) Deed -- (Type, Number of Parcels)

33 (xxiii) Zoning -- (Permitted use, Classification) "Buyers of real estate in the state of  
34 Rhode Island are legally obligated to comply with all local real estate ordinances; including, but

1 not limited to, ordinances on the number of unrelated persons who may legally reside in a  
2 dwelling, as well as ordinances on the number of dwelling units permitted under the local zoning  
3 ordinances." If the subject property is located in a historic district, that fact must be disclosed to  
4 the buyer, together with the notification that "property located in a historic district may be subject  
5 to construction, expansion or renovation limitations. Contact the local building inspection official  
6 for details."

7 (xxiv) Restrictions -- (Plat or Other)

8 (xxv) Building Permits

9 (xxvi) Minimum Housing -- (Violations)

10 (xxvii) Flood Plain -- (Flood Insurance)

11 (xxviii) Wetlands -- The location of coastal wetlands, bay, fresh water wetlands, pond,  
12 marsh, river bank or swamp, as those terms are defined in chapter 1 of title 2 and the associated  
13 buffer areas may impact future property development. The seller must disclose to the buyer any  
14 such determination on all or part of the land made by the department of environmental  
15 management.

16 (xxix) Multi-family or other Rental Property -- (Rental Income)

17 (xxx) Pools & Equipment -- (Type, Defects)

18 (xxxi) Lead Paint -- (Inspection) Every buyer of residential real estate built prior to 1978  
19 is hereby notified that those properties may have lead exposures that may place young children at  
20 risk of developing lead poisoning. Lead poisoning in young children may produce permanent  
21 neurological damage, including learning disabilities, reduced IQ behavioral problems, and  
22 impaired memory. The seller of that property is required to provide the buyer with a copy of any  
23 lead inspection report in the seller's possession and notify the buyer of any known lead poisoning  
24 problem. Environmental lead inspection is recommended prior to purchase.

25 (xxxii) Fire

26 (xxxiii) Hazardous Waste -- (Asbestos and Other Contaminants)

27 (xxxiv) Miscellaneous

28 (xxxv) Farms -- The disclosure shall inform the buyer that any farm(s) that may be in the  
29 municipality are protected by the right to farm law.

30 [\(xxxvi\) Mold -- \(Type, repairs, alterations, modifications\).](#)

33 (c) Any agreement to transfer real estate shall contain an acknowledgement that a  
34 completed real estate disclosure form has been provided to the buyer by the seller in accordance

1 with the provisions of this section.

2 (d) The Rhode Island real estate commission has the right to amend the seller disclosure  
3 requirements by adding or deleting requirements when there is a determination that health, safety,  
4 or legal needs require a change. Any change to requirements shall be a rule change, subject to the  
5 Administrative Procedures Act, chapter 35 of title 42. The power of the commission to amend the  
6 written disclosure requirements shall be liberally construed so as to allow additional information  
7 to be provided as to the structural components, housing systems, and other property information  
8 as required by this chapter.

9 SECTION 2. This act shall take effect on January 1, 2020.

EXPLANATION  
BY THE LEGISLATIVE COUNCIL  
OF

DISCLOSURES

\*\*\*

1           This act would add to the disclosure requirements to be made by the sellers of one to four  
2 (4) units of residential real estate, any modifications made to the electrical, heating, plumbing,  
3 and ventilation systems. It would also require disclosures concerning the type, repairs, alterations,  
4 modifications of any mold, plus any moisture penetration or damage.

5           This act would take effect on January 1, 2020.
