RELATING TO MOTOR AND OTHER VEHICLES - MOTOR VEHICLE OFFENSES

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 31-27-4.1 of the General Laws in Chapter 31-27 entitled "Motor
2 Vehicle Offenses" is hereby amended to read as follows:

3 **31-27-4.1. Eluding a law enforcement officer with a motor vehicle in a high speed**
4 **pursuit.**

5 Any person who in an attempt to elude or flee from a police officer in an emergency
6 police vehicle in a high speed pursuit of the person, operates a motor vehicle at speeds greater
7 than fifteen (15) miles per hour over the speed limit, or who causes property damage only in
8 excess of one thousand dollars (\$1,000): shall upon conviction be guilty of a felony and shall be
9 imprisoned for not more than five (5) years at the adult correction institutions (ACI), and/or be
10 subject to a fine of not less than five thousand dollars (\$5,000) but not more than ten thousand
11 dollars (\$10,000), and may have their license suspended for not less than one year but not more
12 than two (2) years, and may be subject to the forfeiture of the motor vehicle.

13 ~~(1) For the first conviction, may be subject to the following sanctions:~~

14 ~~(i) Up to one year incarceration at the adult correction institutions (A.C.I.) and a fine of~~
15 ~~five hundred dollars (\$500) but not more than one thousand dollars (\$1,000);~~

16 ~~(ii) License suspension of not less than ninety (90) days but not more than six (6) months~~
17 ~~and forfeiture of the motor vehicle.~~

18 ~~(2) For a second or subsequent conviction, the person shall:~~

19 ~~(i) Be sentenced to two (2) years at the A.C.I., but not more than five (5) years;~~

- 1 ~~(ii) Be fined a fine of two thousand dollars (\$2,000) but not more than five thousand~~
2 ~~dollars (\$5,000);~~
3 ~~(iii) Receive a license suspension of not less than one year but not more than five (5)~~
4 ~~years; and~~
5 ~~(iv) Forfeit the motor vehicle.~~

6 SECTION 2. This act shall take effect upon passage.

EXPLANATION
BY THE LEGISLATIVE COUNCIL
OF
A N A C T
RELATING TO MOTOR AND OTHER VEHICLES - MOTOR VEHICLE OFFENSES

1 This act would increase the penalty for anyone found guilty of eluding a police vehicle in
2 high speed pursuit to a felony punishable by up to five (5) years imprisonment, a fine of between
3 five thousand dollars (\$5,000) and ten thousand dollars (\$10,000), a loss of license from one to
4 two (2) years, and a possible forfeiture of their motor vehicle.

5 This act would take effect upon passage.
