It is enacted by the General Assembly as follows: SECTION 1. Chapter 27-18 of the General Laws entitled "Accident and Sickness 1 2 Insurance Policies" is hereby amended by adding thereto the following section: 3 27-18-71. supplement insurance policies, all policies written pursuant to the provisions of this chapter shall

disclose the insurance reimbursement rate to hospitals in this state, including, but not limited to,

reimbursement for matters such as medical services and equipment.

11	supplement insurance policies, all policies written pursuant to the provisions of this chapter shall
12	disclose the insurance reimbursement rate to hospitals in this state, including, but not limited to
13	reimbursement for matters such as medical services and equipment.
