RELATING TO BUSINESSES AND PROFESSIONS - PROPANE GAS SALES

It is enacted by the General Assembly as follows:

1           SECTION 1. Section 5-83-1 of the General Laws in Chapter 5-83 entitled "Propane Gas  
2 Sales" is hereby amended to read as follows:

3           **5-83-1. Requirements for guaranteed price plans, price protection and prepaid**  
4 **contracts. --** (a) A contract for the retail sale of propane gas that offers a guaranteed price plan,  
5 including a ceiling price cap plan contract and any other similar plan, must be disclosed in a way  
6 to clearly define the terms and conditions of the price plan. The disclosure of terms and  
7 conditions must be in plain language, must immediately follow the language concerning the price  
8 or service that could be affected and must be, if initiated verbally, confirmed in writing no more  
9 than fourteen (14) days from the initiation date using no less than twelve (12) point boldface type  
10 of uniform font. The disclosure of terms and conditions, must include, but not be limited to, any  
11 additional fees or costs for securing the guaranteed price, as well as, any early termination fees,  
12 [and shall express the price in terms of the sum of any such fees divided by the number of gallons](#)  
13 [delivered.](#)

14           (b) A solicitation for the retail sale of propane gas that offers a guaranteed price plan,  
15 including a ceiling price cap plan and any other similar plan, must be confirmed in writing no  
16 more than fourteen (14) days from the solicitation date, and the terms and conditions of that offer  
17 must be disclosed in plain language.

18           (c) A propane gas dealer that pays for media or print advertising of a price shall offer  
19 said price for a period of no less than twenty-four (24) hours or until the next advertised price is

1 so publicized, whichever occurs first.

2 (d) No prepaid propane gas contract shall require any consumer commitment to purchase  
3 propane gas pursuant to the terms of such contract for a period of more than twelve (12) months.

4 (e) Any violation of this section shall render the terms and conditions of the  
5 aforementioned contract null and void.

6 SECTION 2. This act shall take effect upon passage.
