2	Lang, a well-respected and astute businessman and the founder of Operation Clean Government

4	WHEREAS, Mr. Lang attended the University of Rhode Island, where he joined the
5	ROTC program. He subsequently served in the United States Army and was one of the last
6	Americans to leave Cuba in 1958. He returned to the states and continued his education, earning
7	an MBA from Harvard Business School in 1961; and
8	WHEREAS, Entering a training program at CBS News opened myriad doors and
9	opportunities for Mr. Lang. He not only accrued invaluable knowledge of the industry, but also
10	collected enviable lifelong memories and experiences, including meeting the Beatles during their
11	appearance on the Ed Sullivan show and posing for camera shots with celebrities such as Sammy
12	Davis, Jr.; and
13	WHEREAS, In 1972, Mr. Lang returned to Rhode Island and worked for his family's
14	business, and later, for the state Department of Economic Development as the head of the Rhode
15	Island Partnership for Science & Technology; and
16	WHEREAS, In 1993, Mr. Lang co-founded Operation Clean Government, a government
17	watchdog group supporting clean and honest state government. In addition, he was President of
18	the Rhode Island Separation of Powers Committee, and served on numerous business,
19	community, and government boards and organizations; and

WHEREAS, In 1991, Mr. Lang was the recipient of the Governor's Science and
