It is enacted by the General Assembly as follows:

1	SECTION 1. Title 31 of the General Laws entitled "MOTOR AND OTHER
2	VEHICLES" is hereby amended by adding thereto the following chapter:
3	CHAPTER 54
4	THE RHODE ISLAND PROTECTION FROM SECONDHAND SMOKE FOR CHILDREN
5	<u>ACT OF 2012</u>
6	31-54-1. Short title This chapter shall be known and may be cited as "The Rhode
7	Island Protection From Secondhand Smoke For Children Act of 2012."
8	31-54-2. Definitions For the purposes of this chapter "motor vehicle" means any
9	motor vehicle, except a school bus, church bus, and other public conveyance, which is required
10	by federal or state law or regulation to be equipped with a passenger restraint system.
11	31-54-3. Prohibition of smoking with child passenger Smoking, as defined in
12	section 23-20.10-2, shall be prohibited in all motor vehicles in which a child is restrained or
13	required to be restrained pursuant to subsection 31-22-22(a).
14	31-54-4. Penalties (a) Any person who violates the provisions of this chapter shall,
15	upon conviction, be punished by a fine not to exceed twenty-five dollars (\$25.00).
16	(b) If a person is convicted, pleads guilty, pleads nolo contendere, or forfeits bond for a
17	violation of this chapter, no court costs or other costs or fees shall be assessed.

(c) Any person who proves to the court that he or she has entered into a smoking

- 1 <u>cessation program may have his or her fine eliminated for a first offense violation of this chapter.</u>
- 2 SECTION 2. This act shall take effect upon passage.

EXPLANATION

BY THE LEGISLATIVE COUNCIL
