It is enacted by the General Assembly as follows:

SECTION 1. Chapter 40-6 of the General Laws entitled "Public Assistance Act" is hereby amended by adding thereto the following section: 40-6-8.1. Prohibited uses of electronic benefit transfer cards. – (a) Notwithstanding

any provision of the general or public laws to the contrary, eligible recipients of direct cash assistance shall not use direct cash assistance funds held on electronic benefit transfer cards for the purchase of alcoholic beverages, lottery tickets or tobacco products. An eligible recipient of

direct cash assistance who makes a purchase in violation of this section shall reimburse the

(b) Notwithstanding any provision of the general or public laws to the contrary, an individual or store owner shall not accept direct cash assistance funds held on electronic benefit transfer cards for the purchase of alcoholic beverages, lottery tickets, or tobacco products. An individual or store owner who knowingly accepts electronic benefit transfer cards in violation of this section shall be punished by a fine of not more than five hundred dollars (\$500) for the first offense, a fine of not less than five hundred dollars (\$500), nor more than one thousand dollars (\$1,000) for the second offense, and a fine of not less than one thousand dollars (\$1,000) for the third or subsequent offense.

(c) The department shall adopt rules prohibiting purchases with cash assistance funds

held on electronic benefit transfer cards of products and services and in venues as described in

this section

1	(d) The department is hereby empowered, and shall maintain policies and practices as
2	necessary to prevent cash assistance provided under this chapter from being used in any
3	electronic benefit transfer transaction at:
4	(1) Liquor stores;
5	(2) Casinos as defined by chapter 41-9.1;
6	(3) Gambling facilities as defined by chapter 41-9;
7	(4) Retail establishments which provide adult-oriented entertainment in which performers
8	disrobe or perform in an unclothed state for entertainment as defined in the social security act,
9	section 42 U.S.C. 608(a);
10	(5) Adult bookstores or adult paraphernalia stores;
11	(6) Firearms dealers licensed under section 11-47-39;
12	(7) Tattoo parlors; manicuring shops, or esthetic shops as defined in section 5-10-1; or
13	(8) Rent-to-own stores, jewelry stores, or on cruise ships.
14	(f) Eligible recipients of direct cash assistance who use cash assistance funds held on
15	electronic benefit transfer cards in such establishments shall have their cash assistance reduced
16	for three (3) months by the portion of the family's benefit attributable to one parent, in
17	accordance with rules and regulations promulgated by the department, for a first offense; for six
18	(6) months by the portion of the family's benefit attributable to one parent for a second offense;
19	and, for a third offense, the department shall terminate assistance to that household.
20	(g) The establishments described in subsection (d) shall not accept electronic benefits
21	transfer cards. A store owner who knowingly allows a prohibited electronic benefit transaction in
22	violation of this section shall be punished by a fine of not more than five hundred dollars (\$500)
23	for a first offense, by a fine of not less than five hundred dollars (\$500) nor more than two
24	thousand five hundred dollars (\$2,500) for a second offense, and by a fine of not less than two
25	thousand five hundred dollars (\$2,500) for a third or subsequent offense.
26	(h) A store owner who knowingly violates this section and who also possesses a license
27	to sell alcoholic beverages under chapter 3-7 shall be referred to the appropriate licensing
28	authority for possible disciplinary action pursuant to title 3.
29	(i) A store owner who knowingly violates this section, and who also possesses a license
30	to sell lottery tickets under chapter 42-61 shall be referred to the director of the state lottery for
31	possible disciplinary action.
32	SECTION 2. This act shall take effect upon passage.

EXPLANATION

BY THE LEGISLATIVE COUNCIL

OF

AN ACT

RELATING TO HUMAN SERVICES - PUBLIC ASSISTANCE ACT

- 1 This act would provide that a recipient of direct cash assistance on electronic benefit 2 cards shall not utilize that benefit to purchase alcoholic beverages, lottery tickets or tobacco 3 products. It would also provide for penalties for violations by recipients, and would also prohibit 4 store owners from accepting the benefit card for the purchase of the above items and provides for penalties for said violations. 5 6 This act would take effect upon passage.
