It is enacted by the General Assembly as follows:

- 1 SECTION 1. Chapter 27-18 of the General Laws entitled "Accident and Sickness
- 2 Insurance Policies" is hereby amended by adding thereto the following section:
- 3 <u>27-18-81. Consumer notification. Every health insurer or health plan providing dental</u>
- 4 <u>benefits to subscribers shall include on the identification card provided to its subscribers on the</u>
- 5 front of the cards the following language when the underlying plan contains a non-duplication of
- 6 <u>benefits clause: "NO DUPLICATION OF BENEFITS".</u>
- 7 SECTION 2. Chapter 27-19 of the General Laws entitled "Nonprofit Hospital Service
- 8 Corporations" is hereby amended by adding thereto the following section:
- 9 <u>27-19-72. Consumer notification.</u> Every nonprofit hospital service corporation
- 10 providing dental benefits to subscribers shall include on the identification card provided to its
- 11 subscribers on the front of the cards the following language when the underlying plan contains a
- 12 <u>non-duplication of benefits clause: "NO DUPLICATION OF BENEFITS".</u>
- SECTION 3. Chapter 27-20 of the General Laws entitled "Nonprofit Medical Service
  Corporations" is hereby amended by adding thereto the following section:
- 15 27-20-68. Consumer notification. -- Every nonprofit medical service corporation
- 16 providing dental benefits to subscribers shall include on the identification card provided to its
- 17 subscribers on the front of the cards the following language when the underlying plan contains a
- 18 non-duplication of benefits clause: "NO DUPLICATION OF BENEFITS".

- SECTION 4. Chapter 27-20.1 of the General Laws entitled "Nonprofit Dental Service
   Corporations" is hereby amended by adding thereto the following section:
- 3 27-20.1-22. Consumer notification. -- Every nonprofit dental service corporation
- 4 providing dental benefits to subscribers shall include on the identification card provided to its
- 5 subscribers on the front of the cards the following language when the underlying plan contains a
- 6 non-duplication of benefits clause: "NO DUPLICATION OF BENEFITS".
- 7 SECTION 5. Chapter 27-41 of the General Laws entitled "Health Maintenance
- 8 Organizations" is hereby amended by adding thereto the following section:
- 9 <u>27-41-85. Consumer notification. --</u> Every health maintenance organization providing
- 10 dental benefits to subscribers shall include on the identification card provided to its subscribers on
- 11 the front of the cards the following language when the underlying plan contains a non-duplication
- 12 of benefits clause: "NO DUPLICATION OF BENEFITS".
- 13 SECTION 6. This act shall take effect on January 1, 2014.
