It is enacted by the General Assembly as follows:

1 SECTION 1. Chapter 41-9.1 of the General Laws entitled "The Rhode Island Gaming
2 Control and Revenue Act" is hereby repealed in its entirety.

4 ~~The Rhode Island Gaming Control and Revenue Act~~

5 ~~**41-9.1-1. Title.** --- This chapter shall be known as the "Rhode Island Gaming Control and
6 Revenue Act."~~

7 ~~**41-9.1-2. Legislative findings.** --- The general assembly makes the following findings:~~

8 ~~(1) In accord with R.I. Const. Art. VI, section 22, only the people of the State of Rhode
9 Island can determine whether the state should pursue casino gaming as a source of revenue;~~

10 ~~(2) The people should be able to make this determination in a manner that is consistent
11 with the Rhode Island Constitution;~~

12 ~~(3) The people should be able to exercise their right and their elected representatives
13 should be able to implement the people's determination based upon clear and objective criteria;~~

14 ~~(4) A potential casino licensee should be provided with clear and objective criteria;~~

15 ~~(5) Casino states have diverse regulatory schemes, but all have strong legislative and
16 regulatory oversight to ensure integrity of casino operations and to maintain public confidence;~~

17 ~~(6) To ensure the integrity of the commercial casino gaming industry and its reputation
18 in Rhode Island, commercial casino gaming needs the strictest possible regulation with law
19 enforcement oversight;~~

1 ~~(7) There are socio-economic costs that expanded gaming may impose on communities~~
2 ~~and the state;~~

3 ~~(8) Problem gambling already exists in Rhode Island and may increase with the~~
4 ~~introduction of casino gaming;~~

5 ~~(9) The state of Rhode Island should follow the lead of other casino jurisdictions and~~
6 ~~take measures designed to detect the extent of problem gambling, educate the public, and assure~~
7 ~~availability of resources for treatment.~~

8 ~~**41-9.1-3. Definitions.** As used in this chapter, the following terms are defined as~~

10 ~~(1) "Adjusted gross receipts" means the gross receipts less winnings paid to wagerers.~~

11 ~~(2) "Affiliate" means a person who, directly or indirectly, through one or more~~
12 ~~intermediaries, controls, is controlled by, or is under common control with; is in a partnership~~
13 ~~(general or limited) or joint venture relationship with; or is a co-shareholder of a corporation, a~~
14 ~~co-member of a limited liability company, or co-partner in a limited liability partnership with a~~
15 ~~person who holds or applies for a casino license under this chapter.~~

16 ~~(3) "Affiliated company" means any form of business organization which controls, is~~
17 ~~controlled by or is under common control with, is in a partnership (general or limited) or joint~~
18 ~~venture relationship with, or is a co-shareholder of a corporation, a co-member of a limited~~
19 ~~liability company, or co-partner in a limited liability partnership with a person who holds or~~

22 ~~state lottery division, the state police, or attorney general who is assigned to perform full-time~~

25 ~~(5) "Applicant" means any person who applies for any right, license or registration under~~

27 ~~(6) "Casino" means a building in which gaming is conducted.~~

28 ~~(7) "Casino licensee" or "casino operator" means any person licensed to conduct gaming~~
29 ~~operations according to the provisions of this chapter.~~

30 ~~(8) "Chairperson" means the chairperson of the state lottery division.~~

31 ~~(9) "Commission" means the state lottery division as created by chapter 61 of title 42.~~

32 ~~(10) "Company" means a sole proprietorship, corporation partnership (general or~~
33 ~~limited), limited liability partnership, limited liability company, trust, association, joint stock~~
34 ~~company, joint venture tribal corporation or other form of business organization.~~

1 ~~(11) "Compensation" means any money, thing of value or financial benefit conferred on~~
2 ~~or received by a person in return for services rendered or to be rendered, whether by that person~~

4 ~~(12) "Conflict of interest" means a situation in which the private interest of a member,~~
5 ~~employee, or agent of the state lottery division may influence the judgment of the member,~~
6 ~~employee, or agent in the performance of his or her public duty under this chapter. A conflict of~~
7 ~~interest includes, but is not limited to, the following:~~

8 ~~(i) Any conduct that would lead a reasonable person knowing all of the circumstances, to~~
9 ~~conclude that the member, employee, or agent of the state lottery division is biased against or in~~
10 ~~favor of an applicant.~~

11 ~~(ii) Acceptance of any form of compensation other than from the state lottery division,~~
12 ~~for any services rendered as part of or related to the official duties of the member, employee, or~~
13 ~~agent for the state lottery division.~~

14 ~~(iii) Participation in any business being transacted with or before the state lottery~~
15 ~~division, in which the member, employee, or agent of the state lottery division, or his or her~~
16 ~~parent, spouse or child, has a financial interest.~~

17 ~~(iv) Use of the position, title, or any related authority of the member, employee, or agent~~
18 ~~of the state lottery division in a manner designed for personal gain or benefit.~~

19 ~~(v) Demonstration through work or other action in the performance of the official duties~~
20 ~~of the member, employee, or agent of the state lottery division of any preferential attitude or~~
21 ~~treatment of any person.~~

22 ~~(13) "Control" means having a greater than twenty percent (20%) direct or indirect~~
23 ~~pecuniary interest in the gaming operation with respect to which the license is sought.~~

24 ~~(14) "Development agreement" means a written agreement between an applicant for a~~
25 ~~casino license and the Town of West Warwick pertaining to the casino including, but not limited~~
26 ~~to, approval of the location of the site and the process for addressing and approving zoning, land~~
27 ~~use, utility and other essential services, on-site and off-site improvements, local impacts and~~
28 ~~construction and operational issues.~~

29 ~~(15) "Disciplinary action" is an action by the state lottery division suspending or~~
30 ~~revoking a license, fining, excluding, reprimanding or otherwise penalizing a person for violating~~
31 ~~this chapter or rules promulgated by the state lottery division.~~

32 ~~(16) "Financial interest" or "financially interested" means any interest in investments,~~
33 ~~awarding of contracts, grants, loans, purchases, leases, sales, or similar matters under~~
34 ~~consideration or consummated by the state lottery division. A member, employee, or agent of the~~

1 ~~state lottery division will be considered to have a financial interest in a matter under consideration~~
2 ~~if any of the following circumstances exist:~~

10 ~~including, but not limited to faro, monte, roulette, keno, bingo fan tan, twenty one, blackjack,~~
11 ~~seven and a half, klondike, craps, poker, chuck a luck, Chinese chuck a luck (dai shu), wheel of~~
12 ~~fortune, chemin de fer, baccarat, pai gow, beat the banker, panguingui, slot machine, any banking~~
13 ~~or percentage game, or any other game or device approved by the state lottery division, but does~~
14 ~~not include games played with cards in private homes or residences in which no person makes~~

16 ~~(18) "Game" means any banking or percentage game located exclusively within a~~
17 ~~licensed casino, which is played with cards, dice, or any electronic, electrical, or mechanical~~
18 ~~device or machine for money, property, or any thing of value.~~

19 ~~(19) "Gaming" means to deal, operate, carry on, conduct, maintain or expose or offer for~~
20 ~~play any gambling game or gaming operation.~~

21 ~~(20) "Gaming device" means any equipment or mechanical, electromechanical, or~~
22 ~~electronic contrivance component or machine used directly or indirectly in connection with~~
23 ~~gaming or any game which affects the result of a wager by determining win or loss. The term~~
24 ~~includes a system for processing information, which can alter the normal criteria of random~~
25 ~~selection which affects the operation of any game or which determines the outcome of a game.~~
26 ~~The term does not include a system or device, which affects a game solely by stopping its~~
27 ~~operation so that the outcome remains undetermined.~~

28 ~~(21) "Gaming operation" means the conduct of authorized gambling games in a casino~~
29 ~~pursuant to this chapter but does not include those operations governed by chapters 61 and 61.2~~
30 ~~of Title 42.~~

31 ~~(22) "Gaming supplier" means any person who supplies, sells or leases or contracts to~~
32 ~~sell or lease gaming devices, equipment, or supplies to a holder of a license or a casino gaming~~
33 ~~operator.~~

34 ~~(23) "Gaming supplier permit" means the permit of a gaming supplier.~~

1 ~~(24) "Gaming supplies" means all materials and supplies other than gaming devices~~
2 ~~which the state lottery division finds or determines to be used or expended in gaming operations~~
3 ~~or activities and that can impact the outcome of game.~~

4 ~~(25) "Gross receipts" means the total of all sums including valid or invalid checks,~~
5 ~~currency, tokens, coupons, vouchers, or instruments of monetary value whether collected or~~
6 ~~uncollected, received by a casino licensee from gaming, including all entry fees assessed for~~
7 ~~tournaments or other contests less a deduction for uncollectible gaming receivables not to exceed~~
8 ~~the uncollectible amounts owed as a result of wagers placed at or through a gambling game or~~
9 ~~four percent (4%) of the total gross receipts, whichever is less. The licensee shall not receive the~~
10 ~~deduction unless the licensee provides written proof to the state treasurer of the uncollected~~
11 ~~gaming receivable and has complied with all rules promulgated by the state lottery division~~
12 ~~regarding the issuance of credit and the collection of amounts due under a credit extension.~~

32 ~~agency or instrumentality of a state or its political subdivisions for the benefit of its employees.~~

33 ~~(d) Any trust fund, the trustee of which is a bank or trust.~~

34 ~~(e) Any investment adviser registered with the United States Securities and Exchange~~

2 ~~(f) Any real estate investment trust registered with the United States Securities and~~

9 ~~(46) "Wagerer" means a person who plays a gambling game authorized under this~~
10 ~~chapter.~~

11 ~~(47) "Wagering tax revenue" means the tax revenue to the state derived from the taxes~~
12 ~~imposed on the adjusted gross receipts of the casino licensee in accordance with section 41-9.1-~~

18 ~~(a) In addition to its powers and duties set forth in chapter 61 of title 42, the state lottery~~
19 ~~division shall have the powers and duties specified within this chapter and all other powers~~
20 ~~necessary and proper to fully and effectively execute and administer the provisions of this chapter~~
21 ~~for its purpose of licensing, regulating and enforcing the system of casino gaming.~~

22 ~~(b) By January 31st of each year, each member of the state lottery division shall prepare~~
23 ~~and file with the office of the state lottery division, a member disclosure form in which the~~
24 ~~member does all of the following:~~

25 ~~(1) Affirms that the member or the member's spouse, parent, child, or child's spouse is~~

- 17 ~~(f) Any member, employee, or agent of the state lottery division who is negotiating for,~~
18 ~~or acquires by any means any interest in any person who is a licensee or an applicant, or any~~
19 ~~person affiliated with such a person, shall immediately provide written notice of the details of the~~
20 ~~interest to the chairperson. The member, employee, or agent of the state lottery division shall not~~
21 ~~act on behalf of the state lottery division with respect to that person.~~
- 22 ~~(g) A member, employee, or agent of the state lottery division may not enter into any~~

18 the state. The legislature further finds that an essential element of the operation, regulation and
19 control of casino gaming by the state requires public confidence and trust in the credibility and
20 integrity of those casino gaming activities. Therefore, in order to safeguard the integrity of casino
21 gaming activities, the legislature finds that it is necessary to establish a casino gaming unit within
22 the Rhode Island state police to, inter alia, assist in conducting due diligence investigations and
23 background investigations of individuals and entities, to assist regulatory authorities in
24 monitoring and investigating potential criminal activity and to assist with the prosecution of
25 crimes related to casino gaming activities.

26 **42-61.3-2. Gaming enforcement unit.** -- (a) The superintendent of the state police shall
27 establish a gaming enforcement unit within the state police.

2 (d) The gaming enforcement unit's responsibilities shall include, but not be limited to:

3 (1) Conducting due diligence investigations and background investigations with respect
4 to entities and individuals required to be licensed by the division and/or the department of
5 business regulation;

6 (2) Monitoring for and investigating potential criminal activity; and

7 (3) Taking any and all actions necessary to enforce the criminal laws related to casino
8 gaming activities.

9 (e) Any and all individuals and/or entities licensed by the division of state lottery and/or
10 the department of business regulation shall cooperate with the gaming enforcement unit in the
11 performance of its duties.

12 (f) The gaming enforcement unit may independently conduct gaming related
13 investigations and background investigations that require out-of-state travel. It shall be the
14 responsibility of the applicant and/or licensee, as applicable, to reimburse the state police for all
15 travel-related expenses incurred while conducting gaming-related investigations and background
16 investigations.

17 (g) Notwithstanding any other provisions of the general laws, members of the gaming
18 enforcement unit shall have the power to enter the premises of a gaming facility licensed by the
19 division of state lottery at any time, to the extent permissible under the constitutions of the state
20 of Rhode Island and the United States of America, through its investigators and law enforcement
21 personnel at any time without notice for the following purposes:

22 (1) To inspect and examine the premises of a gaming facility where casino gaming
23 activities are conducted;

24 (2) To inspect, examine and/or seize any and all tangible property related to casino
25 gaming activities;

26 (3) To inspect, examine, seize and/or audit all computers, books, ledgers, documents,
27 writing, photocopies, correspondence, records, videotapes, including electronically stored
28 records, money receptacles, other containers and their contents, and equipment in or on which the
29 records are stored at a licensed gaming facility, its parking areas and/or adjacent buildings and
30 structures;

31 (4) To inspect any person on the premises of a gaming facility, its parking areas and/or
32 adjacent buildings and structures and inspect, examine, and seize personal effects while that
33 person is present in said facility, its parking areas and/or adjacent buildings and structures;

34 (5) To conduct criminal investigations into violations of the criminal laws or the rules and

1 regulations promulgated thereto;

2 (6) To eject, exclude or authorize the ejection or exclusion of a person from a gaming
3 facility if the person allegedly violated any criminal law, or when the division of state lottery or
4 the casino gaming unit determines that the person's conduct or reputation is such that his or her
5 presence within the gaming facility may compromise the honesty and integrity of casino gaming
6 activities or interfere with the orderly conduct of casino gaming activities. Nothing herein shall
7 preclude any other law enforcement or regulatory agency from having similar authority as
8 otherwise permitted by law or regulation; and

9 (7) Take any and all other actions as may be reasonable or appropriate to carry out their
10 duties and responsibilities under this chapter.

11 **42-61.3-3. Casino gaming crimes.** -- (a) Definitions as used in this chapter:

12 (1) "Casino gaming" shall have the meaning set forth in the Rhode Island general laws
13 subdivision 42-61.2-1(8).

14 (2) "Cheat" means to alter the element of chance, method of selection, or criteria which
15 determines:

16 (i) The result of the game;

17 (ii) The amount or frequency of payment in a game, including intentionally taking
18 advantage of a malfunctioning machine;

19 (iii) The value of a wagering instrument; or

20 (iv) The value of a wagering credit.

21 (3) "Cheating device" means any physical, mechanical, electromechanical, electronic,
22 photographic, or computerized device used in such a manner as to cheat, deceive or defraud a
23 casino game. This includes, but is not limited to:

24 (i) Slugs, plastic, tape, string or dental floss placed inside a coin or bill acceptor or any
25 other opening in a video lottery terminal in a manner to simulate coin or currency acceptance, and
26 is thereafter withdrawn;

27 (ii) Forged or stolen keys used to gain access to a casino game to remove its contents; and

28 (iii) Game cards or dice that have been tampered with, marked or loaded.

29 (4) "Gaming facility" means any facility authorized to conduct casino gaming as defined
30 in the Rhode Island general laws subdivision 42-61.2-1(8), including its parking areas and/or
31 adjacent buildings and structures.

32 (5) "Paraphernalia for the manufacturing of cheating devices" means the equipment,
33 products or materials that are intended for use or designed for use in manufacturing, producing,
34 fabricating, preparing, testing, analyzing, packaging, storing or concealing a counterfeit facsimile

1 of the chips, tokens, debit instruments or other wagering devices approved by the division of state
2 lottery or lawful coin or currency of the United States of America. This term includes, but is not
3 limited to:

4 (i) Lead or lead alloy molds, forms, or similar equipment capable of producing a likeness
5 of a gaming token or United States coin or currency;

6 (ii) Melting pots or other receptacles;

7 (iii) Torches, tongs, trimming tools or other similar equipment; and

8 (iv) Equipment that can be used to manufacture facsimiles of debit instruments or
9 wagering instruments approved by the division of state lottery.

10 (6) "Table game" shall have the meaning set forth in Rhode Island general laws
11 subdivision 42-61.2-1(11).

12 (7) "Wager" means a sum of money or representative of value that is risked on an
13 occurrence for which the outcome is uncertain.

14 (b) Prohibited Acts and Penalties. It shall be unlawful for any person to:

15 (1) Use, or attempt to use, a cheating device in a casino game or to have possession of
16 such a device in a gaming facility. Any person convicted of violating this section shall be guilty
17 of a felony punishable by imprisonment for not more than ten (10) years or a fine of not more
18 than one hundred thousand dollars (\$100,000), or both;

19 (2) Use, acquire, or possess, or attempt to use, acquire or possess, paraphernalia used to
20 manufacture cheating devices. Any person convicted of violating this section shall be guilty of a
21 felony punishable by imprisonment for not more than ten (10) years or a fine of not more than
22 one hundred thousand dollars (\$100,000), or both;

23 (3) Cheat, or attempt to cheat, in order to take or collect money or anything of value,
24 whether for one's self or another, in or from a casino game in a gaming facility. Any person
25 convicted of violating this section shall be guilty of a felony punishable by imprisonment for not
26 more than ten (10) years or a fine of not more than one hundred thousand dollars (\$100,000), or
27 both;

28 (4) Conduct, carry on, operate, deal, or attempt to conduct, carry on, operate or deal, or
29 allow to be conducted, carried on, operated, or dealt, any cheating game or device. Any person
30 convicted of violating this section shall be guilty of a felony punishable by imprisonment for not
31 more than ten (10) years or a fine of not more than one hundred thousand dollars (\$100,000), or
32 both;

33 (5) Manipulate or alter or attempt to manipulate or alter, with the intent to cheat, any
34 physical, mechanical, electromechanical, electronic, or computerized component of a casino

1 game, contrary to the designed and normal operational purpose for the component. Any person
2 convicted of violating this section shall be guilty of a felony punishable by imprisonment for not
3 more than ten (10) years or a fine of not more than one hundred thousand dollars (\$100,000), or
4 both;

5 (6) Use, sell or possess, or attempt to use, sell or possess, counterfeit: coins, slugs,
6 tokens, gaming chips, debit instruments, player rewards cards or any counterfeit wagering
7 instruments and/or devices resembling tokens, gaming chips, debit or other wagering instruments
8 approved by the division of state lottery for use in a casino game in a gaming facility. Any person
9 convicted of violating this section shall be guilty of a felony punishable by imprisonment for not
10 more than ten (10) years or a fine of not more than one hundred thousand dollars (\$100,000), or
11 both;

12 (7)(i) Place, increase, decrease, cancel or remove a wager or determine the course of play
13 of a table game, or attempt to place, increase, decrease, cancel or remove a wager or determine
14 the course of play of a table game, with knowledge of the outcome of the table game where such
15 knowledge is not available to all players; or

16 (ii) Aid, or attempt to aid anyone in acquiring such knowledge for the purpose of placing,
17 increasing, decreasing, cancelling or removing a wager or determining the course of play of the
18 table game. Any person convicted of violating this section shall be guilty of a felony punishable
19 by imprisonment for not more than ten (10) years or a fine of not more than one hundred
20 thousand dollars (\$100,000), or both;

21 (8) Claim, collect or take, or attempt to claim, collect or take, money or anything of value
22 in or from a casino game or gaming facility, with intent to defraud, or to claim, collect or take an
23 amount greater than the amount won. Any person convicted of violating this section shall be
24 guilty of a felony punishable by imprisonment for not more than ten (10) years or a fine of not
25 more than one hundred thousand dollars (\$100,000), or both;

26 (9) For any employee of a gaming facility or anyone acting on behalf of or at the
27 direction of an employee of a gaming facility, to knowingly fail to collect, or attempt to fail to
28 collect, a losing wager or pay, or attempt to pay, an amount greater on any wager than required
29 under the rules of a casino game. Any person convicted of violating this section shall be guilty of
30 a felony punishable by imprisonment for not more than ten (10) years or a fine of not more than
31 one hundred thousand dollars (\$100,000), or both;

32 (10) Directly or indirectly offer, or attempt to offer, to conspire with another, or solicit, or
33 attempt to solicit, from another, anything of value, for the purpose of influencing the outcome of
34 a casino game. Any person convicted of violating this section shall be guilty of a felony

1 punishable by imprisonment for not more than ten (10) years or a fine of not more than one
2 hundred thousand dollars (\$100,000), or both;

3 (11) Use or possess, or attempt to use or possess, at a gaming facility, without the written
4 consent of the director of the division of state lottery, any electronic, electrical or mechanical
5 device designed, constructed or programmed to assist the user or another person in:

6 (i) Predicting the outcome of a casino game;

7 (ii) Keeping track of the cards played;

8 (iii) Analyzing and/or predicting the probability of an occurrence relating to the casino
9 game; and/or

10 (iv) Analyzing and/or predicting the strategy for playing or wagering to be used in the
11 casino game. Any person convicted of violating this section shall be guilty of a felony punishable
12 by imprisonment for not more than ten (10) years or a fine of not more than one hundred
13 thousand dollars (\$100,000), or both;

14 (12) Skim, or attempt to skim, casino gaming proceeds by excluding anything of value
15 from the deposit, counting, collection, or computation of:

16 (i) Gross revenues from gaming operations or activities;

17 (ii) Net gaming proceeds; and/or

18 (iii) Amounts due the state pursuant to applicable casino gaming-related laws. Any
19 person convicted of violating this section shall be guilty of a felony punishable by imprisonment
20 for not more than ten (10) years or a fine of not more than one hundred thousand dollars
21 (\$100,000), or both;

22 (13) Cheat, or attempt to cheat, in the performance of his/her duties as a dealer or other
23 casino employee by conducting one's self in a manner that is deceptive to the public or alters the
24 normal random selection of characteristics or the normal chance or result of the game, including,
25 but not limited to, using cards, dice or any cheating device(s) which have been marked, tampered
26 with or altered. Any person convicted of violating this section shall be guilty of a felony
27 punishable by imprisonment for not more than ten (10) years or a fine of not more than one
28 hundred thousand dollars (\$100,000), or both;

29 (14) Possess or use, or attempt to use, without proper authorization from the state lottery
30 division, while in the gaming facility any key or device designed for the purpose of or suitable for
31 opening or entering any self-redemption unit (kiosk), vault, video lottery terminal, drop box or
32 any secured area in the gaming facility that contains casino gaming and/or surveillance
33 equipment, computers, electrical systems, currency, cards, chips, dice, or any other thing of value.
34 Any person convicted of violating this section shall be guilty of a felony punishable by

1 imprisonment for not more than ten (10) years or a fine of not more than one hundred thousand
2 dollars (\$100,000), or both;

3 (15) Tamper and/or interfere, or attempt to tamper and/or interfere, with any casino
4 gaming and/or surveillance equipment, including, but not limited to, related computers and
5 electrical systems. Any person convicted of violating this section shall be guilty of a felony
6 punishable by imprisonment for not more than ten (10) years or a fine of not more than one
7 hundred thousand dollars (\$100,000), or both;

8 (16) Access, interfere with, infiltrate, hack into or infect, or attempt to access, interfere
9 with, infiltrate, hack into or infect, any casino gaming-related computer, network, hardware
10 and/or software or other equipment. Any person convicted of violating this section shall be guilty
11 of a felony punishable by imprisonment for not more than ten (10) years or a fine of not more
12 than one hundred thousand dollars (\$100,000), or both;

13 (17) Sell, trade, barter, profit from or otherwise use to one's financial advantage, or
14 attempt to sell, trade, barter, profit from or otherwise use to one's financial advantage, any
15 confidential information related to casino-gaming operations, including, but not limited to, data
16 (whether stored on a computer's software, hardware, network or elsewhere), passwords, codes,
17 surveillance and security characteristics and/or vulnerabilities, and/or non-public internal
18 controls, policies and procedures related thereto. Any person convicted of violating this section
19 shall be guilty of a felony punishable by imprisonment for not more than ten (10) years or a fine
20 of not more than one hundred thousand dollars (\$100,000), or both;

21 (18) Conduct a gaming operation, or attempt to conduct a gaming operation, where
22 wagering is used or to be used without a license issued by the division of state lottery. Any
23 person convicted of violating this section shall be guilty of a felony punishable by imprisonment
24 for not more than ten (10) years or a fine of not more than one hundred thousand dollars
25 (\$100,000), or both;

26 (19) Provide false information and/or testimony to the division of state lottery,
27 department of business regulation, or their authorized representatives and/or the state police while
28 under oath. Any person convicted of violating this section shall be guilty of a felony punishable
29 by imprisonment for not more than ten (10) years or a fine of not more than one hundred
30 thousand dollars (\$100,000), or both;

31 (20) Play a casino game and/or make a wager, or attempting to play a casino game and/or
32 make a wager, if under the age eighteen (18) years. Any person convicted of violating this section
33 be guilty of a misdemeanor punishable by imprisonment for not more than one year or a fine of
34 not more than one thousand dollars (\$1,000), or both; or

1 (21) Permit, or attempt to permit, a person to play a casino game and/or accept, or
2 attempt to accept, a wager from a person, if he/she is under the age of eighteen (18) years. Any
3 person convicted of violating this section be guilty of a misdemeanor punishable by
4 imprisonment for not more than one year or a fine of not more than one thousand dollars
5 (\$1,000), or both.

6 **42-61.3-4. Barred from gaming facility; Restitution; Confiscation.** -- (a) In addition,
7 anyone so convicted of any crime above may be barred for a period of time, including life, from
8 any gaming facility.

9 (b) Upon conviction of either a felony or misdemeanor in this chapter, the sentencing
10 judge may require full restitution for any monetary losses suffered.

11 (c) Any cheating device, paraphernalia used to manufacture cheating devices, counterfeit:
12 coins, slugs, tokens, gaming chips, debit instruments, player rewards cards or any counterfeit
13 wagering instruments and/or devices resembling tokens, gaming chips, debit or other wagering
14 instruments or any other equipment or real or personal property used, obtained or received in
15 violation of this chapter, shall be confiscated by the division of state lottery, the gaming facility
16 and/or the gaming enforcement unit of the state police and shall be forfeited to the gaming
17 enforcement unit. This section shall include the confiscation and forfeiture of vehicles containing
18 any item(s) listed above.

19 **42-61.3-5. Limitation of liability.** -- The licensee's officers, and/or any duly authorized
20 employees of the licensee, and/or the division may question and detain for a reasonable amount of
21 time in accordance with Rhode Island law, any individual(s) suspected of violating any provision
22 of this chapter, while awaiting the arrival of law enforcement officials. No officer or duly
23 authorized employee of the licensee or the division of state lottery shall be held criminally or
24 civilly liable for such actions.

25 **42-61.3-6. Additional crimes.** -- The criminal offenses under this chapter shall be in
26 addition to any other offenses under the general laws and nothing in this chapter shall be
27 construed so as to prohibit the prosecution for any other such offenses.

28 SECTION 4. Section 42-61.2-2.1 of the General Laws in Chapter 42-61.2 entitled "Video
29 Lottery Terminal" is hereby amended to read as follows:

30 **42-61.2-2.1. State authorized to operate casino gaming.** -- (a) State-operated casino
31 gaming shall be authorized at the facility of the licensed video lottery terminal retailer known as
32 "Twin River" located in the town of Lincoln; provided, that the requirements of Article VI,
33 Section 22 of the Rhode Island Constitution are met with respect to said facility at the general
34 election next held after enactment of this section.

1 (1) With respect to the "Twin River" facility, the authorization of this section 2.1 shall be
2 effective upon: (i) The certification by the secretary of state that the qualified voters of the state
3 have approved the expansion of gambling at such facility to include casino gaming; and (ii) The
4 certification by the board of canvassers of the town of Lincoln that qualified electors of the town
5 of Lincoln have approved the expansion of gambling at such facility to include casino gaming.

6 (b) The general assembly finds that:

7 (1) The operation of casino gaming at Twin River will play a critical role in the economy
8 of the state and enhance state and local revenues;

9 (2) Pursuant to Article VI, Section 15 of the Rhode Island Constitution and the specific
10 powers, authorities and safeguards set forth in subsection (c) herein in connection with the
11 operation of casino gaming, the state shall have full operational control over the specified
12 location at which casino gaming shall be conducted;

13 (3) It is in the best interest of the state to have the authorization to operate casino gaming
14 as specified at Twin River; and

15 (4) It is in the best interest of the state to conduct an extensive analysis and evaluation of
16 competitive casino gaming operations and thereafter for the general assembly to enact
17 comprehensive legislation during the 2012 legislative session to determine the terms and
18 conditions pursuant to which casino gaming would be operated in the state if it is authorized as
19 set forth herein.

20 (c) Notwithstanding the provisions of any other law and pursuant to Article VI, Section
21 15 of the Rhode Island Constitution, the state is authorized to operate, conduct and control casino
22 gaming at Twin River, subject to subsection (a) above. In furtherance thereof, the state, through
23 the division of state lottery and/or the department of business regulation, shall have full
24 operational control to operate the foregoing facility, the authority to make all decisions about all
25 aspects of the functioning of the business enterprise, including, without limitation, the power and
26 authority to:

27 (1) Determine the number, type, placement and arrangement of casino gaming games,
28 tables and sites within the facility;

29 (2) Establish with respect to casino gaming one or more systems for linking, tracking,
30 deposit and reporting of receipts, audits, annual reports, prohibitive conduct and other such
31 matters determined from time to time;

32 (3) Collect all receipts from casino gaming, require that Twin River collect casino
33 gaming gross receipts in trust for the state through the division of state lottery, deposit such
34 receipts into an account or accounts of its choice, allocate such receipts according to law, and

1 otherwise maintain custody and control over all casino gaming receipts and funds;

2 (4) Hold and exercise sufficient powers over Twin River's accounting and finances to
3 allow for adequate oversight and verification of the financial aspects of casino gaming at the
4 facility, including, without limitation:

5 (i) The right to require Twin River to maintain an annual balance sheet, profit and loss
6 statement, and any other necessary information or reports; and

7 (ii) The authority and power to conduct periodic compliance or special or focused audits
8 of the information or reports provided, as well as the premises with the facility containing records
9 of casino gaming or in which the business of Twin River's casino gaming operations are
10 conducted;

11 (5) Monitor all casino gaming operations and have the power to terminate or suspend
12 any casino gaming activities in the event of an integrity concern or other threat to the public trust,
13 and in furtherance thereof, require the licensed video lottery retailer to provide a specified area or
14 areas from which to conduct such monitoring activities;

15 (6) Define and limit the rules of play and odds of authorized casino gaming games,
16 including, without limitation, the minimum and maximum wagers for each casino gaming game;

17 (7) Have approval rights over matters relating to the employment of individuals to be
18 involved, directly or indirectly, with the operation of casino gaming at Twin River;

19 (8) Establish compulsive gambling treatment programs;

20 (9) Promulgate, or propose for promulgation, any legislative, interpretive and procedural
21 rules necessary for the successful implementation, administration and enforcement of this
22 chapter; and

23 (10) Hold all other powers necessary and proper to fully effectively execute and
24 administer the provisions of this chapter for its purpose of allowing the state to operate a casino
25 gaming facility through a licensed video lottery retailer hosting said casino gaming on behalf of
26 the State of Rhode Island.

27 (d) Subject to subsection (a) above, the state, through the division of state lottery and/or
28 the department of business regulation, may expand Twin River existing video lottery license
29 issued, or issue Twin River a new casino gaming license, to permit casino gaming to the extent
30 authorized by this act.

31 (e) Subject to subsection (a) above, all rules and regulations shall be promulgated by the
32 state, through the division of state lottery and the department of business regulation, in
33 accordance with the authority conferred upon the general assembly pursuant to Article VI,
34 Section 15 of the Rhode Island Constitution. In accord therewith, subject to subsection (a) above,

1 the state, through the division of state lottery and/or the department of business regulation, shall
2 have authority to issue such regulations as it deems appropriate pertaining to control, operation
3 and management of casino gaming as specifically set forth in subsections (b) and (c) herein.

4 [\(f\) The Rhode Island state police through its gaming enforcement unit shall have the](#)

6 [consistent with chapter 42-61.3](#)

7 SECTION 5. This act shall take effect upon passage.
