17	flourished, and a home that was warm and welcoming. She doted on her family, and particularly
18	enjoyed attending school events, and spending time with and hearing of the accomplishments of
19	her five beautiful grandchildren, Drew Kennedy Prouty, Ronald John Kennedy, Nicholas
