RELATING TO HUMAN SERVICES - PUBLIC ASSISTANCE-FRAUD PREVENTION

It is enacted by the General Assembly as follows:

1 SECTION 1. Chapter 40-6 of the General Laws entitled "Public Assistance Act" is 2 hereby amended by adding thereto the following section: 3 40-6-8.1. Electronic benefit transfer cards for supplemental nutrition assistance 4 program (SNAP). -- The department shall: 5 (1) Require the use of photo identification on the front of each newly issued and reissued electronic benefit transfer card for each cardholder who is over the age of eighteen (18); provided, 6 7 however, that the department shall promulgate regulations to ensure that all authorized users and 8 members of the household are able to use an electronic benefit transfer card pursuant to 7 U.S.C. 9 2016(h)(9); provided further, that the department shall not require the use of photo identification 10 for individuals who are sixty (60) years of age or over, blind, disabled or victims of domestic violence; and provided, further, that in developing regulations for authorized users, the 11 12 department shall consult with businesses or vendor associations whose members accept electronic 13 benefit transfer cards as a form of payment including, but not limited to, the Rhode Island Food 14 Dealers Association and the New England Convenience Store Association; and 15 (2) Include the fraud hotline number and department website on all newly issued electronic benefit transfer cards; and 16 17 (3) Require that any retailer that accepts electronic benefit transfer cards to post the fraud 18 hotline number provided by the department; and 19 (4) List on each application and renewal forms items prohibited from purchase with

- 1 <u>electronic benefit transfer cards; and</u>
- 2 (5) Send a notice to any benefit recipient who requests more than three (3) replacement
- 3 <u>electronic benefit transfer cards in a calendar year and monitor future requests for replacement</u>
- 4 cards; provided that the notice shall state that the department has noted an unusual number of
- 5 requests for replacement electronic benefits cards and will be monitoring all future requests for
- 6 replacement cards.
- 7 SECTION 2. This act shall take effect on September 1, 2015.

1	This act would require the department of human services to issue electronic benefit
2	transfer cards containing a photograph of the cardholder if they are over the age of eighteen (18),
3	under the age of sixty (60) and not blind, disabled or victims of domestic violence. This act would
4	also require the department to implement certain procedures designed to reduce fraud and abuse.
5	This act would take effect on September 1, 2015.
