RELATING TO STATE AFFAIRS AND GOVERNMENT - DEPARTMENT OF ENVIRONMENTAL MANAGEMENT

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 42-17.1-8 of the General Laws in Chapter 42-17.1 entitled
2 "Department of Environmental Management" is hereby amended to read as follows:
3 **42-17.1-8. Designation and assignment of functions.** -- Whenever the duties of the head
4 of any existing department, division, board, commission, or other agency or of any other officer
5 are prescribed by law, and the duties of such person have been or shall in the future be transferred
6 to the department of environmental management under this chapter, the director of the department
7 of environmental management may designate some officer or other subordinate within his or her
8 department to perform such duties; provided, however, that any other provision of this chapter
9 notwithstanding, the functions, powers and duties of the chief of the division of parks and
10 recreation as set forth in title 32, entitled "Parks and Recreational Areas," as amended, in chapter
11 22.5 of title 23, entitled "Drowning Prevention and Lifesaving," as amended, and in any other
12 general or public law, and the functions, powers, and duties of the chief of the division of harbors
13 and rivers as set forth in title 46, entitled "Waters and Navigation," as amended, and in any other
14 general or public law, shall not be diminished; provided further, however, that all planning and
15 law enforcement functions, powers, duties, and personnel shall be transferred to the divisions
16 established by §§ 42-17.1-4~~(E)~~ (5) and 42-17.1-4~~(F)~~ (6) of this chapter. Provided, that oversight
17 of and over all freshwater lakes, streams, and ponds within the state shall be with a newly created
18 position within the division of fish and wildlife.

1 SECTION 2. Section 42-17.1-4 of the General Laws in Chapter 42-17.1 entitled
2 "Department of Environmental Management" is hereby amended to read as follows:

3 **42-17.1-4. Divisions within department.** -- Within the department of environmental
4 management there are established the following divisions:

5 (1) A division of parks and recreation that shall carry out those functions of the
6 department relating to the operation and maintenance of parks and recreation areas and the
7 establishment and maintenance of such additional recreation areas as may from time to time be
8 acquired and such other functions and duties as may from time to time be assigned by the
9 director;

10 (2) A division of fish and wildlife that shall carry out those functions of the department
11 relating to the administration of hunting, fishing, and shell fisheries; the preservation of wetlands,
12 marsh lands, [freshwater lakes, streams, ponds](#) and wildlife; and such other functions and duties as
13 may from time to time be assigned by the director;

14 (3) A division of agriculture that shall carry out those functions of the department
15 relating to agriculture, and such other functions and duties as may from time to time be assigned
16 by the director, including, but not limited to, plant industry, farm viability, marketing and
17 promotion, farmland ecology and protection, plant and animal health and quarantine, pesticides,
18 mosquito abatement, pest survey and response, food policy and security, and, in collaboration
19 with the department of health, public health as it relates to farm production and direct marketing
20 of farm products, and those agreed upon through memorandum of agreement with the department
21 of health or other state agencies. The department of health shall continue to act as the lead agency
22 for all public health issues in the state pursuant to chapter 1 of title 23. Nothing herein contained
23 shall limit the department of health's statutory authority, nor shall any provision herein be
24 construed as a limitation upon the statutory authority of the department of health granted to the
25 department under title 23 of the general laws, nor shall any provision herein be construed to limit
26 the authority of the department of environmental management to enter into memoranda of
27 agreement with any governmental agency. The chief of the division of agriculture shall report
28 directly to the director.

29 (4) A division of coastal resources that shall carry out those functions of the department
30 relating to harbors and harbor lines, pilotage, flood control, shore development, construction of
31 port facilities, and the registration of boats and such other functions and duties as may, from time
32 to time, be assigned by the director, except that the division shall not be responsible for the
33 functions of inspection of dams and reservoirs, approving plans for construction or improvement
34 of dams, reservoirs, and other structures in non-tidal waters, and the operation of stream-gauging

1 stations in cooperation with the United States Geological Survey, and provided, further, that the
2 division and its staff shall be responsible through the director of environmental management, to
3 the coastal resources management council, and the chief and the staff of the division shall serve
4 as staff to the council;

5 (5) A division of planning and development that shall carry out those functions of the
6 department relating to planning, programming, acquisition of land, engineering studies, and such
7 other studies, as the director may direct, and that shall work with the board of governors for
8 higher education and the board of regents for elementary and secondary education, with
9 educational institutions at all levels, and with the public in the dissemination of information and
10 education relating to natural resources, and shall perform the publication and public relations
11 functions of the department, the functions of inspection of dams and reservoirs, approving plans
12 for construction or improvement of dams, reservoirs, and other structures in non-tidal waters, and
13 the operation of stream-gauging stations in cooperation with the United States Geological Survey;

14 (6) A division of enforcement that shall enforce all of the laws and regulations of the
15 department and the coastal resources management council, that shall cooperate with the other
16 enforcement agencies of the state and its municipalities, and that shall administer all of the
17 policing, enforcing, licensing, registration, and inspection functions of the department and such
18 other functions and duties as may, from time to time, be assigned by the director;

19 (7) A division of forest environment that shall carry out those functions of the
20 department relating to the administration of forests and natural areas, including programs for
21 utilization, conservation, forest fire protection, and improvements of these areas; assisting other
22 agencies and local governments in urban programs relating to trees, forests, green belts, and
23 environment and such other functions and duties as may, from time to time, be assigned by the
24 director; and

25 (8) (i) A division of boating safety that shall carry out those functions of the department
26 relating to the development and administration of a coordinated, safe boating program in
27 accordance with the Model Safe Boating Act of 1971 as approved by the National Association of
28 State Boating Law Administrators.

29 (ii) Administration of the division of boating safety shall be the responsibility of the state
30 boating law administrator whose duties shall include:

31 (A) The enforcement of all laws relating to the act; and

32 (B) The powers vested in the state boating law administrator and boating safety
33 enforcement officer shall include the enforcement of laws, rules and regulations relating to
34 "Regulation of Boats," chapter 22 of title 46 and shall also include the power to:

1 (I) Execute all warrants and search warrants for the violation of laws, rules, and
2 regulations relating to the act.

3 (II) Serve subpoenas issued for the trial of all offenses hereunder.

4 (III) To carry firearms or other weapons, concealed or otherwise, in the course of, and in
5 performance of, their duties under this chapter.

6 (IV) To arrest without warrant and on view any person found violating any law, rule, or
7 regulation relating to the act; take that person before a court having jurisdiction for trial; detain
8 that person in custody at the expense of the state until arraignment; and to make and execute
9 complaints within any district to the justice or clerk of the court against any person for any of the
10 offenses enumerated under the act committed within the district.

11 (V) Boating safety enforcement officers shall not be required to give surety for costs
12 upon any complaint made by him or her.

13 (iii) The development and administration of a coordinated, safe boating program.

14 (iv) The establishment and enforcement of such rules and regulations as are deemed
15 necessary to achieve the purposes of the Model Safe Boating Act as approved by the state boating
16 law administrators.

17 (v) The state boating law administrator shall serve as the liaison to the United States
18 Coast Guard.

19 SECTION 3. This act shall take effect upon passage.

BY THE LEGISLATIVE COUNCIL
