It is enacted by the General Assembly as follows:

- 1 SECTION 1. Chapter 24-8 of the General Laws entitled "Construction and Maintenance
- 2 of State Roads" is hereby amended by adding thereto the following section:
- 3 <u>24-8-45. Maintenance of certain roads in the city of Providence. -- (a)</u>

4 Notwithstanding the provisions of § 24-8-1.3, or any other act or state law, the state director of

5 transportation, by and through his or her designees, shall be responsible for the maintenance cost,

6 reconstruction, snow and ice removal, construction, and maintenance of the roads, adjoining

7 curbs, and sidewalks, drainage, and installation, and maintenance of traffic signals located in the

8 <u>city of Providence as set forth in subsection (b) of this section; and these public highways shall be</u>

- 9 designated as state highways, as further defined in § 31-1-23(j).
