EXPLANATION

BY THE LEGISLATIVE COUNCIL

OF

AN ACT

RELATING TO HEALTH AND SAFETY-- DEPARTMENT OF HEALTH -- FEES

1 This act would provide that only in-state wholesale food processors shall be subject to the

2 five hundred dollar (\$500) fee charged by the department of health, thereby exempting out-of-

3 state wholesale food processors from such fee.

4 This act would take effect on July 1, 2017.
