RELATING TO ELECTIONS - REPORTING OF POLITICAL CONTRIBUTIONS BY STATE VENDORS

It is enacted by the General Assembly as follows:

1 SECTION 1. Chapter 17-27 of the General Laws entitled "Reporting of Political
2 Contributions by State Vendors" is hereby amended by adding thereto the following sections:

3 **17-27-6. Prohibition of political contributions.** -- (a) Any state vendor who contracts
4 with state agencies, in the aggregate, annually more than five thousand dollars (\$5,000), and any
5 affiliated entities of such state vendor, are prohibited from making any contributions to any
6 political committees established to promote the candidacy of:

7 (1) The officeholder responsible for awarding the contracts; or

8 (2) Any other declared candidate for that office. This prohibition shall be effective for the
9 duration of the term of office of the incumbent officeholder awarding the contracts or for a period
10 of two (2) years following the expiration or termination of the contracts, whichever is longer.

11 (b) Any state vendor whose aggregate pending bids and proposals for contract with state
12 agencies total more than five thousand dollars (\$5,000), or whose aggregate pending bids and
13 proposals for contract with state agencies combined with the state vendor's aggregate annual total
14 value of state contracts exceed twenty five thousand dollars (\$25,000), and any affiliated entities
15 of such state vendor, are prohibited from making any contributions to any political committee
16 established to promote the candidacy of the officeholder responsible for awarding the contract on
17 which the business entity has submitted a bid or proposal during the period beginning on the date
18 the invitation for bids or request for proposals is issued and ending on the day after the date the

1 contract is awarded.

2 (c) All contracts between state agencies and a state vendor that violate subsections (a) or
3 (b) of this section shall be voidable at the option of the state agencies. If a state vendor violates
4 subsection (a) of this section three (3) or more times within a thirty-six (36) month period, then
5 all contracts between state agencies and that state vendor shall be void, and that state vendor shall
6 not bid or respond to any invitation to bid or request for proposals from any state agency or
7 otherwise enter into any contract with any state agency for three (3) years from the date of the last
8 violation. A notice of each violation and the penalty imposed shall be published on the website of
9 the board of elections.

10 (d) Any political committee that has received a contribution in violation of subsection (a)
11 or (b) of this section shall pay an amount equal to the value of the contribution to the state no
12 more than thirty (30) days after notice of the violation from the board of elections. Payments
13 received by the state pursuant to this subsection shall be deposited into the general revenue fund.

14 **17-27-7. Severability. --** If the provisions of this act or its application to any person or
15 circumstance are held invalid, the invalidity of that provision or application does not affect the
16 other provisions or applications of this act that can be given effect without the invalid provision
17 or application.

18 SECTION 2. Section 17-27-1 of the General Laws in Chapter 17-27 entitled "Reporting
19 of Political Contributions by State Vendors" is hereby amended to read as follows:

20 **17-27-1. Definitions. --** As used in this chapter:

21 (1) "Aggregate amount" means the total of all contributions made to a particular general
22 officer, candidate for general office, or political party within the time period set forth;

23 (2) "Business entity" means a sole proprietorship, partnership, firm, corporation, holding
24 company, joint stock company, receivership, trust, or any other entity recognized in law through
25 which business for profit is conducted;

26 (3) "Contribution" means a transfer of money, paid personal services, or other thing of
27 value reportable under the terms of chapter 25 of this title;

28 (4) "Executive officer" means any person who is appointed or elected as an officer of a
29 business entity by either the incorporators, stockholders, or directors of the business entity who is
30 in charge of a principal business unit, division, or function of the business entity, or participates
31 or has authority to participate other than in the capacity of a director in major policymaking
32 functions of the business entity or who is actively engaged in soliciting business from the state or
33 conducting, other than in a ministerial capacity, business with the state; ~~provided, that officers of~~
34 ~~the business entity who are located outside the state, are not residents of the state, and do not~~

1 ~~participate in the business of the business entity within this state shall be exempted from the~~
2 ~~requirements of this chapter;~~

3 (5) "Goods or services" shall ~~not include services provided to a state agency by:~~ include,
4 but not be limited to, cost reimbursement contracts or contingency fee contracts;

5 ~~(i) Any public utility company; or~~

6 ~~(ii) A federal or state banking institution or other depository institution solely in~~
7 ~~connection with depository accounts held by the institution on behalf of a state agency;~~

8 (6) "State agency" means a branch, department, division, agency, commission, board,
9 office, bureau, or authority of the government of the state of Rhode Island;

10 (7) (i) "State vendor" means:

11 (A) A person or business entity that sells goods or provides services to any state agency,

12 (B) A person or business entity which has an ownership interest of ten (10%) percent or
13 more in a business entity that sells goods or provides services to any state agency, or

14 (C) A person who is an executive officer of a business entity that sells goods or provides
15 services to any state agency,

16 (D) The spouse or minor child of a person qualifying as a state vendor under the terms of
17 subparagraphs (A), (B) or (C) of this paragraph, ~~unless the spouse works for a vendor in~~
18 ~~competition for state business with the reporting business entity, or~~

19 (E) A business of the business entity that is a parent or subsidiary of a business entity
20 that sells goods or provides services to any state agency; or

21 (F) A person or business entity that bids to sell goods or provide services to any state
22 agency.

23 (ii) "State vendor" does not mean:

24 (A) A municipality,

25 ~~(B) A corporation established pursuant to Section 501(c)(3) of the Internal Revenue~~
26 ~~Code, 26 U.S.C. § 501(c)(3);~~

27 ~~(C) A hospital;~~

28 ~~(D) A state or federal agency, or~~

29 ~~(E)(C) A person receiving reimbursement for an approved state expense. The director of~~
30 ~~administration is authorized to provide as a public record a list of further exemptions consistent~~
31 ~~with the purposes of this chapter.~~

32 (8) "Officeholder" means the governor, lieutenant governor, attorney general, secretary of
33 state, general treasurer, and members of the joint committee on legislative services or candidate
34 for the aforementioned offices. The governor shall be considered the officeholder responsible for

1 awarding all contracts by all officers and employees of, and vendors and others doing business
2 with, executive branch state agencies not within the jurisdiction of lieutenant governor, the
3 attorney general, the secretary of state, the general treasurer or members of the joint committee on
4 legislative services.

5 (9) "Affiliated entity" means:

6 (i) Any subsidiary of the bidding or contracting business entity;

7 (ii) Any member of the same unitary business group as the bidding or contracting
8 business entity;

9 (iii) Any organization recognized by the United States Internal Revenue Service as a tax-
10 exempt organization described in section 501(c) of the Internal Revenue Code of 1986 (or any
11 successor provision of federal tax law) established by the bidding or contracting business entity;

12 or

13 (iv) Any political committee established for the bidding or contracting business entity.

14 SECTION 3. This act shall take effect upon passage.
