It is enacted by the General Assembly as follows:

1 SECTION 1. Section 11-37.1-11 of the General Laws in Chapter 11-37.1 entitled "Sexual

Offender Registration and Community Notification" is hereby amended to read as follows:

11-37.1-11. Release of information.

- (a) Except as otherwise provided by this chapter or as provided in subsections (b) or (c) 4 5 of this section, no information obtained under this chapter shall be released or transferred without
- 6 the written consent of the person or his or her authorized representative.
- 7 (b) No consent for release or transfer of information obtained under this chapter shall be 8 required in the following instances:
- 9 (1) Information may be disclosed to law enforcement agencies for law enforcement purposes;
- 11 (2) Information may be disclosed to government agencies conducting confidential 12 background checks;
- 13 (3) The designated law enforcement agency and any local law enforcement agency 14 authorized by the state agency may release relevant information that is necessary to protect individuals concerning a specific person required to register under this chapter, except that the 15 identity of a victim of an offense that requires registration under this section shall not be released; 16
- (4) Information may be released or disseminated in accordance with the provisions of § 17
- 18 11-37.1-12; and

1	(5) Information shall be disclosed by the local police department to the general public in
2	a city or town for those registered offenders determined to be either a level 2 or level 3 offender
3	as determined consistent with parole board guidelines-; and
4	(6) Information shall be disclosed by the local police department to the local school
5	department for those registered offenders determined to be level 3 offenders by the parole board
6	for the purposes of notifying parents of students whose bus stop is within one thousand feet
7	(1,000') of a level 3 sex offender's residence.
8	(c) Any local law enforcement agency shall release relevant information collected
9	pursuant to § 11-37.1-3(c) to any campus police agency appointed pursuant to § 16-15-2 or police
10	for private institutions appointed pursuant to § 12-2.1-1 for any person having a duty to register
11	who is enrolled in, employed by or carrying on a vocation at an institution of higher education.
12	That agency may release relevant information that is necessary to protect individuals concerning

a specific person required to register under this chapter, except that the identity of a victim of an
