RELATING TO AERONAUTICS -- THEODORE FRANCIS GREEN STATE AIRPORT

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 1-2-17 of the General Laws in Chapter 1-2 entitled "Airports and
2 Landing Fields" is hereby amended to read as follows:

3 **1-2-17. Payment for compensation for municipal services to the city of Warwick.**

4 The Rhode Island airport corporation, from a parking surcharge at the T.F. Green state
5 airport as defined by a 1988 agreement between the state acting by and through the director of
6 transportation and the city of Warwick, shall pay to the city of Warwick out of the parking
7 revenue received at T.F. Green state airport as compensation for municipal services provided at
8 T.F. Green state airport a sum of not less than ~~two hundred seventy five thousand dollars~~
9 ~~(\$275,000) for fiscal year 1994~~ one million four hundred thousand dollars (\$1,400,000) payable
10 quarterly; for each fiscal year after ~~1994~~ 2016, this sum may be reviewed and/or renegotiated by
11 the mayor of the city of Warwick and the airport corporation, but in no event will the sum be less
12 than ~~five hundred thousand dollars (\$500,000)~~ one million two hundred fifty thousand dollars
13 (\$1,250,000) in any fiscal year ~~beginning after 1993 and before 2005, or less than seven hundred~~
14 ~~fifty thousand dollars (\$750,000) in any fiscal year beginning after 2004~~, provided any payments
15 provided or any portion of these payments is not disapproved by the F.A.A. In the event that the
16 F.A.A. disapproves this payment from the airport corporation, the state shall pay to the city of
17 Warwick the sums of money required to insure that the city of Warwick receives ~~five hundred~~
18 ~~thousand dollars (\$500,000)~~ one million two hundred fifty thousand dollars (\$1,250,000).

1 SECTION 2. This act shall take effect upon passage.

RELATING TO AERONAUTICS -- THEODORE FRANCIS GREEN STATE AIRPORT

1 This act would increase the yearly amount of money the state airport corporation pays to
2 the city of Warwick as payment for the municipal services it provides to them from five hundred
3 thousand dollars (\$500,000) to one million four hundred thousand dollars (\$1,400,000).

4 This act would take effect upon passage.
