### RELATING TO MOTOR AND OTHER VEHICLES - REGISTRATION OF VEHICLES

It is enacted by the General Assembly as follows:

1 SECTION 1. Chapter 31-3 of the General Laws entitled "Registration of Vehicles" is 2 hereby amended by adding thereto the following section: 3 31-3-117. Special plate for Day of Portugal and Portuguese Heritage in RI, Inc. 4 (a) The administrator of the division of motor vehicles is empowered to make available 5 special motor vehicle registration plates for the not-for-profit Day of Portugal and Portuguese Heritage in RI, Inc. The plates shall be designed to reference Day of Portugal and Portuguese 6 7 Heritage in RI, Inc. 8 (b) The special plate shall be displayed upon the same registration number assigned to the 9 vehicle for which it was issued, and shall be used in place of and in the same manner as the 10 registration plates issued to the vehicle. The original registration plates for the vehicle shall be 11 removed from the vehicle and returned to the division of motor vehicles. The registration 12 certificate for the plates shall be carried in the vehicle, in accordance with § 31-3-9. The 13 registration certificate shall be in effect for the special plate. 14 (c) Day of Portugal and Portuguese Heritage in RI, Inc. motor vehicle plates shall be the 15 same size as regular motor vehicle plates, and shall be designed by Day of Portugal and Portuguese Heritage in RI, Inc. in conjunction with the division of motor vehicles, with the design 16 17 approved by the RI state police.

(d) Day of Portugal and Portuguese Heritage in RI, Inc. plates shall be subject to a

minimum pre-paid order of at least nine hundred (900) sets of plates per plate type (i.e. passenger,

1	commercial, etc.). Day of Portugal and Portuguese Heritage in RI, Inc. plates shall not be issued
2	unless the minimum order(s) requirements are met. The initial order will be handled by Day of
3	Portugal and Portuguese Heritage in RI, Inc., and shall not be submitted to the division of motor
4	vehicles for production until the minimum order(s) have been met, and the proper paperwork
5	submitted to the division.
6	(e) The administrator of the division of motor vehicles shall develop application forms,
7	pre-payment procedures and any other procedures deemed necessary to carry out the purposes of
8	this section.
9	(f) In addition to the regular prescribed motor vehicle registration fee, Day of Portugal
10	and Portuguese Heritage in RI, Inc. plates shall be subject to a forty dollar (\$40.00) issuance
11	surcharge.
12	(g) The forty dollar (\$40.00) issuance surcharge shall be allocated as follows:
13	(1) Twenty dollars (\$20.00) shall be allocated to the general fund and the remaining
