Bylaws Bylaws and rules and regulations. 4 (a) The bylaws of the association must shall provide for: 5 (1) The number of members of the executive board and the titles of the officers of the association; 6 7 (2) Election by the executive board of a president, treasurer, secretary, and any other officers of the association the bylaws specify; 8 9 (3) The qualifications, powers and duties, terms of office, and manner of electing and removing executive board members and officers and filling vacancies; 10 (4) Which, if any, of its powers the executive board or officers may delegate to other 11 12 persons or to a managing agent; 13 (5) Which of its officers may prepare, execute, certify and record amendments to the 14 declaration on behalf of the association; and 15 (6) The method of amending the bylaws. (b) Subject to the provisions of the declaration, the bylaws may provide for any other 16 17 matters the association deems necessary and appropriate.

(c) Notwithstanding anything to the contrary in this chapter, condominium associations

with five (5) or more condominium units subject to the provisions of this chapter shall have the

- 6 to the bylaws and/or rules and regulations shall be prepared, executed, recorded, and certified on
- 7 <u>behalf of the condominium association by an officer of the condominium association designated</u>
- 8 for that purpose, or in the absence of such designation, by the president of the condominium
- 9 <u>association.</u>

SECTION 2. This act shall take effect upon passage.
