It is enacted by the General Assembly as follows:

1           SECTION 1. Sections 5-6-2 and 5-6-8 of the General Laws in Chapter 5-6 entitled  
2 "Electricians" are hereby amended to read as follows:

3           **5-6-2. Work for which license required.**

4           (a)(1) No person, firm, or corporation shall enter into, engage in, solicit, advertise, bid for,  
5 or work at the business of installing, maintaining, servicing, and testing wires, conduits, apparatus,  
6 which includes support systems specifically for electrical equipment and devices, fixtures,  
7 electrical signs, lightning-protection equipment as defined in § 5-6-1, lighting, control of electrical  
8 devices, handling and removal for installation or re-installation of all electrical equipment, devices,  
9 apparatus, and similar items provided in this subsection within the confines of the jobsite, and other  
10 appliances for carrying or using or generating electricity for light, heat, fire alarms, as defined in  
11 chapter 28.25 of title 23, entitled "Fire Alarm Systems," or power purposes, exclusive of low-  
12 voltage wiring for heating/refrigeration equipment, or work at the business of removing and  
13 reattaching existing electrical meters, unless that person, firm, or corporation shall have received a  
14 license and a certificate for the business, issued by the state board of examiners of electricians of  
15 the division of professional regulation of the department of labor and training in accordance with  
16 the provisions set forth in this chapter.

17           (2) That person shall carry this license on his or her person at all times while so engaged,  
18 and shall affix his or her contractor's license number to any advertisement and/or contract he or she  
19 executes and/or to any bid he or she files with any consumer for his or her professional services

1 and to any applicable permit required for the performance of those services.

2 (b) Any person, firm, or corporation that is required to apply for a permit from a local  
3 building official for any work required to be performed by a person licensed under the provisions  
4 of this chapter shall cause the work to be performed by a person licensed under the provisions of  
5 this chapter; provided, that the provisions of this section, except the provision regarding removing  
6 and reattaching existing electrical meters, shall not apply to owner-occupied, single-family homes.

7 **5-6-8. Contractor's certificates/licenses.**

8 (a) Electrical contractor's license. A Certificate A shall be issued to any person, firm, or  
9 corporation, qualified under this chapter, engaging in, or about to engage in, the business of  
10 installing, maintaining, servicing, and testing electrical wires, conduits, apparatus, [which includes](#)  
11 [support systems specifically for electrical equipment and devices](#), fixtures, fire alarm and safety  
12 communication systems, and other electrical appliances, [lighting, control of electrical devices,](#)  
13 [handling and removal for installation or re-installation of all electrical equipment, devices,](#)  
14 [apparatus, and similar items provided in this subsection within the confines of the jobsite](#), excluding  
15 low-voltage wiring for heating, ventilating, and air conditioning equipment. The certificate shall  
16 specify the name of the person, firm, or corporation applying for it and the name of the person, who  
17 in the case of a firm is one of its members, and in the case of a corporation, is one of its officers,  
18 passing the examination by which he or she or it is authorized to enter upon, or engage in, business  
19 as prescribed in the certificate. The holding of a Certificate A does not entitle the holder  
20 individually to engage in or perform the actual work of installing, maintaining, servicing, and  
21 testing electric wires, conduits, or appliances as previously described in this chapter, but entitles  
22 him or her to conduct business as an electrical contractor.

23 (b) Burner contractor's license. A Certificate E shall be issued to any person, firm, or  
24 corporation qualified under this chapter and engaged in, or about to engage in, the business of a  
25 burner contractor as defined in § 5-6-1. The certificate shall specify the name of the person, firm,  
26 or corporation applying for it and the name of the person who, in the case of a firm is one of its  
27 members, and in the case of a corporation is one of its officers, passing the examination, by which  
28 he or she or it is authorized to enter upon, or engage in, business as prescribed in the certificate.  
29 The holding of a Certificate E does not entitle the holder individually to engage in or perform any  
30 work on, or in connection with, electric wires, conduits, and appliances as previously described in  
31 this chapter, but entitles the holder to contract to do that work, to the extent permitted in this chapter,  
32 through the employment of burnerpersons holding a Certificate F. A burner contractor who is the  
33 holder of a Certificate A is not required to obtain a Certificate E.

34 (c) Fire alarm contractor's license. A Certificate AF shall be issued to any person, firm, or

1 corporation qualified under this chapter and engaged in, or about to engage in, the business of a  
2 fire alarm contractor as defined in § 5-6-1. The certificate shall specify the name of the person,  
3 firm, or corporation applying for it and the person who, in the case of a firm is one of its members,  
4 and in the case of a corporation is one of its officers, passing the examination by which he or she  
5 or it is authorized to enter upon, or engage in, business as prescribed in the certificate. The holding  
6 of a Certificate AF does not entitle the holder individually to engage in, or perform and work on,  
7 or in connection with, electric wires, fire alarm wires, conduits, and appliances as previously  
8 described in this chapter, but entitles the holder to contract to do that work to the extent permitted  
9 in this chapter through the employment of fire alarm installers holding a Certificate BF. A  
10 contractor who is the holder of a Certificate A is not required to obtain a Certificate BF.

11 (d) Electrical sign contractor's license. A Certificate SCF shall be issued to any person,  
12 firm, or corporation qualified under this chapter and engaged in or about to engage in the business  
13 of electrical sign installations, as defined in § 5-6-1.

14 (e) Lightning-protection contractor. A Certificate LPC shall be issued to any person, firm,  
15 or corporation qualified under this chapter and engaged in, or about to engage in, the business of  
16 lightning-protection contractor as defined in § 5-6-1. The Certificate LPC shall specify the name  
17 of the person, firm, or corporation applying for it and the person, who in the case of a firm, is one  
18 of its members, and in the case of a corporation, is one of its officers, passing the examination by  
19 which he or she or it is authorized to enter upon or engage in business as prescribed in the certificate.  
20 The holding of a Certificate LPC does not entitle the holder individually to engage in, or perform  
21 and work on, or in connection with, the installation of lightning-protection equipment as defined in  
22 § 5-6-1, unless that individual also holds a Certificate LPI, but entitles the holder to contract to do  
23 that work to the extent permitted in this chapter through the employment of lightning-protection  
24 installers holding a Certificate LPI.

25 (f) Sign renovation electrical license. A certificate SRL shall be issued to any person, firm,  
26 or corporation qualified under this chapter and engaged in, or about to engage in, the business of  
27 sign renovation or installation of signs when such renovation or installation requires the removal  
28 or installation of no more than three (3) wires.

29 (g) Renewable energy professional. A Certificate REP shall be issued to any person, firm,  
30 or corporation, qualified under this chapter, engaged in or about to engage in the business of  
31 installing eligible renewable energy technologies as defined in § 39-26-5. All renewable energy  
32 electrical work, including installing, connecting, maintaining, servicing, and testing all electrical  
33 wires, conduits, and apparatus; mounting the modules to the mounting racks; mounting the  
34 inverters; and tying the inverters into the main electrical panels, shall be done by a licensed

1 electrician. Ancillary non-electrical, renewable energy work, such as advertising services;  
2 distribution of palletized materials to final ~~location~~ area of installation ~~including photovoltaic~~  
3 ~~modules to the mounting racks~~; and installing the ground and rooftop support brackets and ballast  
4 for rack systems, may be done by any person, firm, or corporation holding a Certificate REP. The  
5 Certificate REP shall specify the name of the person, firm, or corporation applying for it and the  
6 name of the person, who in the case of a firm is one of its members, and in the case of a corporation,  
7 is one of its officers, meeting the requisite education and experience as established in § 5-6-11, by  
8 which he or she or it is authorized to enter upon, or engage in, business as prescribed in the  
9 certificate. The holding of a Certificate REP entitles the holder to contract to do that work to the  
10 extent permitted in this chapter.

11           The installation, mechanical fastening, and conjoining of listed solar sheathing systems  
12 that are ten kilowatts (10 kw) or less on residential structures as defined by the Rhode Island one-  
13 and two-family dwelling code may be performed by a registered contractor who or that has been  
14 issued a renewable energy professional certificate (Certificate REP) as defined in § 5-6-11(e) and  
15 above referenced. However, said residential solar sheathing system shall be connected to the  
16 electrical system from the roof edge and energized by a Rhode Island licensed electrician working  
17 in compliance with this chapter. Additionally, the residential solar sheathing systems noted must  
18 be listed and labeled by UL or other recognized electrical device certification organization,  
19 identified and acceptable by the authority having jurisdiction.

20           SECTION 2. This act shall take effect upon passage.

EXPLANATION  
BY THE LEGISLATIVE COUNCIL

1           This act would include, under the types of electrical work required to be performed by  
2 persons or firms that have an electrical contractor's license, the installation, maintenance, securing  
3 and testing of wires, conduits and apparatus, which includes support systems specifically for  
4 electrical equipment and devices and for lighting, control of electrical devices, and the handling  
5 and removal for installation or re-installation of all electrical equipment, devices and apparatus.

6           This act would take effect upon passage.
