"Forty-seventh district: The forty-seventh representative district shall consist of all of that part of the town of Burrillville bounded by a line beginning at the intersection of Sherman Farm Rd and the Rhode Island-Massachusetts state boundary line; thence westerly along the Rhode Island-Massachusetts boundary line to the Connecticut - Rhode Island boundary line; thence southerly along the Connecticut - Rhode Island boundary line to the Burrillville - Glocester boundary line; thence easterly on the Burrillville - Glocester boundary line to the Burrillville North Smithfield boundary line; thence northerly on the Burrillville - North Smithfield boundary line to Nichols Rd; thence westerly on Nichols Rd to Tarklin Brook; thence southwesterly along Tarklin Brook to Nichols Pond; thence southwesterly through Nichols Pond to census block 440070130024020; thence northwesterly on the boundary line between census blocks 440070130024016 and 440070130024020 and census blocks 440070130024011 and 440070130024012 to Barnes Rd; thence westerly on Barnes Rd to Snake Hill Rd; thence

I hereby move to amend 2012 -- S 2178 SUBSTITUTE A, entitled "AN ACT RELATING TO REDISTRICTING OF THE GENERAL ASSEMBLY", as follows:

1. On page 83 , by deleting all of the language on lines 7 through 33 , and by inserting in place thereof the following language:
"Thirty-first district: The thirty-first representative district shall consist of all of that part of the town of North Kingstown bounded by a line beginning at the Exeter -- North Kingstown boundary line and Shermantown Rd; thence northeasterly on Shermantown Rd to Congdon Hill Rd; thence northerly on Congdon Hill Rd to W Allenton Rd; thence northeasterly on W Allenton Rd to Col Rodman Highway; thence northwesterly on Col Rodman Highway to the Amtrak railroad; thence northeasterly on the Amtrak railroad to Stony Ln; thence easterly on Stony Ln to Sedgefield Rd; thence northerly on Sedgefield Rd to Trowbridge Dr; thence easterly on Trowbridge Dr, continuing on the boundary line between census blocks 440090501022000 and 440090501022023 to Post Rd; thence northerly on Post Rd to Newcomb Rd; thence easterly and northerly on Newcomb Rd to Potter Rd; thence northwesterly on Potter Rd to North Quidnessett Rd; thence northeasterly on North Quidnessett Rd to Sandhill Brook; thence northwesterly on Sandhill Brook to the North Kingstown -- Warwick boundary line; thence westerly and northerly on the Warwick -- North Kingstown boundary line to the East Greenwich -- North Kingstown boundary line; thence southwesterly and westerly on the East Greenwich -- North Kingstown boundary line to the Exeter -- North Kingstown boundary line; thence southerly on the Exeter -North Kingstown boundary line to the point of origin.

The thirty-first representative district shall also consist of all of that part of the town of Exeter bounded by a line beginning at the Exeter -- South Kingstown boundary line and South County Trail; thence northeasterly on South County Trail to South Rd; thence northerly on South Rd to Ten Rod Rd; thence easterly on Ten Rod Rd to the Exeter-North Kingstown boundary line; thence southerly on the Exeter -- North Kingstown boundary line to the Exeter -- South Kingstown boundary line; thence westerly on the Exeter -- South Kingston boundary line to the point of origin."
2. On page 83 , by deleting the language on line 34 and on page 84 , by deleting all of the language on lines 1 through 17, and by inserting in place thereof the following language:
"Thirty-second district: The thirty-second representative district shall consist of all of that part of the town of North Kingstown bounded by a line beginning at the Exeter -- North
