Mr. Speaker:

I hereby move to amend 2018 -- H 7865, entitled "AN ACT RELATING TO MOTOR AND OTHER VEHICLES - REGISTRATION OF VEHICLES", as follows:

1. On page 2, line 13, by deleting the language "(1) Twenty" and inserting in place thereof the language "twenty" and combining all language on page 2, lines 12 through 15 into one paragraph.

2. On page 2, between lines 15 and 16, by inserting the following language: "(h) A ten dollar (\$10) surcharge for subsequent registration renewals will go to Day of Portugal and Portuguese Heritage in RI, Inc."

3. On page 2, line 16, by deleting the language "(h)" and inserting in place thereof the language "(i)".

4. On page 2, line 18, by deleting the language "(i)", and inserting in place thereof the language "(j)".

5. On page 2, between lines 19 and 20, by inserting the following language: "(k) In consideration of the receipt of funds from the registration of Day of Portugal and Portuguese Heritage in RI, Inc. plates, the organization must use any Rhode Island sourced funds in and for the benefit of Rhode Island-based charitable organizations."
