(c) The general treasurer may, in effectuating the purposes of this section, engage experts or consultants, including actuaries. All copies of reports prepared by experts and consultants, and costs associated with the reports, shall be made available to the acquirer and to the public. All costs incurred under this provision shall be the responsibility of the acquirer."
