It is enacted by the General Assembly as follows:

1 SECTION 1. The Town of West Warwick is hereby authorized and empowered to issue
2 bonds to an amount not exceeding six million four hundred thousand dollars (\$6,400,000), from
3 time to time under its corporate name and seal, pursuant to an ordinance to be adopted by the
4 Town in accordance with the West Warwick Home Rule Charter and Rhode Island General Laws
5 §45-12-2.

6 SECTION 2. In accordance with §16-7-44 of the general laws, the principal of and
7 interest on such bonds shall be eligible for state housing aid reimbursement.

8 SECTION 3. This project, which was approved by the Commissioner of Elementary and
9 Secondary Education on or about March 22, 2007, shall be and remain eligible for school housing
10 aid.

- 1 SECTION 4. This act serves as the enabling act required by Rhode Island General Laws
- 2 §16-7-44 and shall take effect upon passage.
