RELATING TO EDUCATION -- CERTIFICATION OF TEACHERS

Introduced By: Senators Pichardo, and DiPalma

Date Introduced: February 27, 2014

Referred To: Senate Education

It is enacted by the General Assembly as follows:

1           SECTION 1. Section 16-11-1 of the General Laws in Chapter 16-11 entitled  
2 "Certification of Teachers [See Title 16 Chapter 97 - The Rhode Island Board Of Education Act]"  
3 is hereby amended to read as follows:  
4           **~~16-11-1. Certification of public school teachers required -- Deductions from state aid~~**  
5 **~~for noncompliance~~ Certification of public school teachers required -- Deductions from state**  
6 **~~aid for noncompliance—Substitute teachers.~~ – (a) No person shall be employed to teach, as**  
7 principal or assistant, in any school supported wholly or in part by public money unless the  
8 person shall have a certificate of qualification issued by or under the authority of the board of  
9 regents for elementary and secondary education. Provided, however, that any person who is  
10 employed as a part time speech and language pathologist at the Rhode Island School for the Deaf,  
11 for a period of not less than ten (10) years prior to July 11, 1990, shall not be required to have a  
12 certificate of qualification, and shall be exempt from the provisions of this section which require  
13 the certificate. In case any city or town shall pay or cause to be paid any of the public money to  
14 any person for teaching who did not, at the time of teaching, hold a certificate, except as provided  
15 in subsection (b), then the department of elementary and secondary education shall deduct a sum  
16 equal to the amount so paid from the amount of the state's money due, or which may thereafter  
17 become due, to the city or town, before giving his or her order in favor of the city or town for any  
18 of the public money under the provisions of sections 16-1-10, 16-1-11, and 16-5-22.  
19           (b) Individuals with two (2) or more years of a college education may serve as substitute

1 teachers for no more than forty (40) teaching days in any one teaching assignment during a school  
2 year, regardless of whether the teaching days are consecutive or non-consecutive. The  
3 commissioner of elementary and secondary education may extend this forty (40) days limitation,  
4 for reasons such as for appropriate training of the substitute teacher.

5 SECTION 2. This act shall take effect upon passage.

EXPLANATION  
BY THE LEGISLATIVE COUNCIL

RELATING TO EDUCATION -- CERTIFICATION OF TEACHERS

1           This act would allow individuals with two (2) or more years of a college education to  
2   serve as substitute teachers for no more than forty (40) teaching days in any one assignment  
3   during a school year, whether the teaching days are consecutive or non-consecutive. The  
4   commissioner of elementary and secondary education would extend this forty (40) day limitation  
5   for the appropriate training of the substitute teacher.

6           This act would take effect upon passage.
