**APPENDIX**

## Statement on Autism in Rhode Island-April 21, 2004

Autism is a neurological disorder that profoundly affects a person's ability to communicate, process and respond to sensory information, and form relationships. Individuals with Autism Spectrum Disorders have a range of symptoms and abilities, strengths and challenges.

Autism affects individuals and families across the state of Rhode Island. Although much work has been done to educate and support individuals with Autism, much more remains to be done in response to the apparent increase in the childhood prevalence of Autism Spectrum Disorders in our state of Rhode Island and nationwide.

Our community's response to the increased prevalence of childhood autism should include the key recommendations from the Rhode Island KIDS COUNT Issue Brief: Children with Autism in Rhode Island:

- Improve and centralize accurate and consistent data collection.
- Ensure all young children with a diagnosis of Autism Spectrum Disorder are enrolled in Early Intervention, preschool and school programs that are consistent with national research on effective programming.
- Expand the capacity of the public education system to effectively educate children with autism spectrum disorder in the least restrictive environment across grade levels. This requires increasing state capacity to provide technical assistance to school districts to develop programming consistent with national research and best practices.
