FLOOR AMENDMENT TO 2004 -- H 7322 SUBSTITUTE A

AN ACT RELATING TO REGISTRATION OF VEHICLES

Mr. Speaker:

I hereby move to amend 2004 -- H 7322 SUBSTITUTE A, entitled "AN ACT RELATING TO REGISTRATION OF VEHICLES", as follows:

(1) On page 1, line 9, by inserting the following language: "(2) the model year and the year of

manufacture that are listed on the certificate of title of a street rod vehicle shall be the model year and year of manufacture that the body of such vehicle resembles.” before the letter “(b)”

(2) On page 2, lines 6 and 7, by deleting the language “and emission control inspection”, after the word “inspection”.

(3) On page 2, line 16, by inserting the following language: “(5) A vehicle registered under this section is exempt from any statute that requires periodic vehicle inspections and from any statute that requires the use and inspection of emission controls.” before the numerals “31-3-31.2”

(4) On page 2, line 23, by inserting the following language: “(3) The model year and the year of manufacture that are listed on the certificate of title of a custom vehicle shall be the model year and year of manufacture that the body of such vehicle resembles.” before the letter “(b)”

(5) On page 3, lines 4 and 5, by deleting the language “and emission control inspection” after the word “inspection”.

(6) On page 3, line 14, by inserting the following language: “(f) A vehicle registered under this section is exempt from any statute that requires periodic vehicle inspections and from any statute that requires the use and inspections of emission controls.” before the letter “(f)” 7) On page 3, line 14, by deleting the letter “(f)” and inserting in place thereof the letter “(g)”.
